No. MAP. 31/72. 26th October, 1972—The Administrator of Mizoram, is pleased to order that the services of Sarvashri M. Dawngliana, Election Officer, Aizawl and M. C. Goswami, A.D.C. Lunglei, are placed with immediate effect at the disposal of the Chief Electoral Officer, Mizoram, in connection with the conduct of Elections to the three District Councils. During the course of performance of such duties outside their Headquarters they will be treated as on tour.

2. Further, Deputy Commissioners, Aizawl and Lunglei are requested to similarly depute two Assistants each from their establishments.

3. Shri M. Dawngliana, with the two Assistants from Deputy Commissioner's Establishment, Aizawl and Shri M.C. Goswami, with two Assists from the Deputy Commissioner's Estt. Lunglei will proceed immediately for reporting at Lawngtlai and Barapansuri, respectively.

4. Action is being taken separately to declare them along with Shri. J.C. Pegu, A.D.C. Saiha, as Additional Returning Officers and during such period till the completion of Elections, all such staff will function under the control of the Returning Officer for Elections to Pawi Lakher and Chakma District Councils.

NO LJD. 20/72/42 the 26th October, 1972—In exercise of powers conferred upon me under provisions of Rule 113 of Pawi-Lakher Autonomous Region (Constitution and Conduct of Business of the Regional Council) Rules, 1963 as adopted under provisions of para 20 B of the Sixth Schedule to the Constitution of India, I, Shri S.P. Mukerjee, Lieutenant Governor (Administrator) of Mizoram hereby appoint the following Officers as Additional Returning Officers for holding and conducting the ensuing General Election to Pawi, Lakher and Chakma Autonomous Districts.
