NOTIFICATION

No.A.12018/19/80-APT (B), the 13th February 1991. In exercise of the powers conferred by the proviso to 309 of the constitution of India, the Governor of Mizoram hereby makes the following Rules to amend the Mizoram Agriculture Department (Group 'A' post) under K.V.K. Recruitment Rules, 1988 under Notification No.A. 12018/19/80-APT(B) dated 26.10.88 and published in the Mizoram Gazette Vol. XVII dated 26.10.88 issue No. 118 namely:—

- 1. Short title & commence-ment.
- 1. These Rules may be called the Govt. of Mizoram, Agriculture Department under K.V.K. (Group 'A' post) Recruitment (First Amendment) Rules, 1991.
- 2. They shall come into force from the date of their publication in the official Gazette.
- 2. In the Schedule/Annexure-I of the Mizoram Agri. Deptt. under KVK (Group 'A' posts) Rectt. Rules, 1988 (hereinafter referred to as the said Rules) for the existing entries under Col. 7 for the posts of Training Associates-Horti./Agri. Extn. & Edn., the following proviso shall be substituted:

"Does not arise"

3. In the Schedule/Annexure-I of the Mizoram Agri. Deptt. under KVK (Group 'A' Posts) Rectt. Rules, 1988 (hereinafter referred to as the said rules) for the existing entries under Col. 8 for the posts of Training Associates Horti/Agri. Extn. & Edn., the following proviso shall be substituted:

"Does not arise"

4. In the Schedule/Annexure-I of the Mizoram Agri. Deptt. under KVK (Group 'A' Posts) Rectt. Rules, 1988 (hereinafter referred to as the said rules) for existing

entries under Col.11 for the posts of Training Associates Horti./Agri. Extn. & Edn., the following proviso shall be substituted:

"100 % by promotion failing which by transfer on deputation/ short term contract."

5. In the Schedule/Annexure-I of the Mizoram Agri. Deptt. under KVK (Group 'A' Posts) Rectt. Rules, 1988 (hereinafter referred to as the said rules) for the existing entries under Col. 12 for the posts of Training Associates-Horti./Agri. Extn. & Edn., the following proviso shall be substituted: "PROMOTION: Officers holding the Grade of SMS/SDAO and all other equivalent posts in the Agri. Deptt. with minimum qualification of M.Sc (Agri. in the line having minimum of 5 (five) years regular service in the grade".

"TRANSFER ON DEPUTATION/CONTRACT: Officer from Central/States/U.T. Admn./Universities/Research Institutes having minimum qualification of M.Sc (Agri) in the line with at least 2yrs. experience in the analogous posts.

(Period of deputation/contract will ordinarily be not exceeding 2yrs, for the first instance)".
