NOTIFICATION

No.B.17011/15/89-TRP: the 14th February, 1991. In supercession to this Department's Notification of even No. 19.6.90 and dt.30.7.90, and in exercise of the powers conferred under section 200 of the Motor Vehicles Act, 1988, the Governor of Mizoram is pleased to appoint the following Officers of Transport Department and Officers of the Police Department as the authorities to compound traffic offences committed under the said Act and punishable under sections mentioned in column 2 or the Schedule below for amounts not more than the ones specified in corresponding column 3 of the said Schedule :-

1. Director of Transport.
2. Joint Director of Transport.
3. Deputy Director of Transport.
4. District Transport Officers/Asstt. District Transport Officer.
5. Motor Vehicle Inspectors.
6. Enforcement cum Traffic Inspectors.
7. Any Police Officer not below the rank of Sub Inspector of Police.
