#### **ACT**

Further to amend the Mizoram Salaries, Allownces and Pension of the Members of the Legislative Assembly Act, 1987.

It is hereby enacted by the Legislative Assembly of Mizoram in the Forty-Second Year of the Republic of India as follows, namely:—

- Short title and commencement
- . (1) This Act may be called the Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly (Amendment) Act, 1991.
  - (2) It shall come into force from the date of its publication in the Official Gazette.
- Amendment of section 2
- 2. In the Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly Act, 1987 (Act No. 6 of 1987), as amended from time to time (hereinafter referred to as the Principal Act) in section 2, for clause (g), the following clause shall be substituted, namely:—
  - (g) "Member" means a member of the Assembly, save as otherwise expressly provided in this Act, does not include -
  - (i) a Minister as defined in the Mizoram Salaries and Allowances of Minister Act, 1987.
  - (ii) the Speaker and the Deputy Speaker as defined in the Mizoram Salaries and Allowances of the Speaker and the Deputy Speaker Act, 1987.

- (iii) the Leader of the Opposition as defined in the Mizoram Salaries and Allowances of Leader of the Opposition Act, 1991; and
- (iv) Government Chief Whip as defined in the Mizoram Salaries and Allowances of the Government Chief Whip Act, 1991;

but includes tne Chief Minister, the Speaker, the Ministers, the Ministers
of State, the Deputy Speaker, the Leader of Opposition
and the Government Chief Whip for the purposes of only
Pension under section 14 and Death Gratuity under section
14 A.

Deletion of section 13A

3.

In the principal Act, section 13A shall be deleted.
