#### NOTIFICATION

- No.A.12018/40/80-APT(B), the 18th March, 1991. In exercise of the powers confered by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the post (s) of Drug Inspector.
- 1. Short title and (i) These rules may be called, the Mizoram Health & Fa-Commencement. mily Welfare Department (Group 'A' post) Recruitment Rules, 1991.
  - (ii) They shall come into force from the date of their publication in the Official Gazette.
- 3. Application. The rules shall apply to the post (s) specified in Col. 1 of the Annexure-I hereto annexed.
- 3. Number of posts, classification and the scale of pay attached thereto shall be as specified in and scale of pay.

  Columns 2 to 4 to the Annexure- I aforesaid.
- 4. Method of rectt. The age limit qualifications and other matters relating to age limit and other the said post shall be as specified in columns 5 to 14 of qualification. the Said Annexure—I.

Provided that the upper age limit prescribed for direct rectt. may be relaxed in the case of candidates belong to the Scheduled Castes Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time.

5. Disqualification:

No person,

a) Who has entered into or contracted a marriage with a person having a spouse living.

b) Who having a spouse living has entered into or contracted marriage with any person shall be eligible for appointment to the said post.

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so exempt any person from the operation of this rules.

6. Training and Departmental Examination :

6 (A)

Every Govt. Servant shall undergo such training or passasuch Departmental Examination as may be prescribed from time to time.

- Notwithstanding anything contained in these Rules, the Governor of Mizoram, in public interest, have the right and power to transfer any Officer or Official, recruited in accordance with these Rules to the post/posts/service specified in Schedule/Annexure to these rules to any other post of position which is equivalent in rank or grade.
- 7. Power to relax:

Where the Governor is of the opinion that it is necessary or expedient so to do, it may by order and for reasons to be recorded in writing in consultation with the Selection Committee/Departmental Promotion Committee through the Department of Personnel & Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category or persons.

- 8. Reservation, other concessions:
- Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt, or Mizoram from time to time in this regards.
- 9. Repeal & Saving:

All Rules pertaining to these posts framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71 - HMT (ii) dt. 21. 1. 1972 are hereby repealed

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.

## ABSTRACTED FROM DRUGS AND COSMETIC ACT 1940, PART V. R-49.

- 49. QUALIFICATION OF INSPECTORS: A person who is appointed an Inspector under the Act shall be a person who-
- (a) has a degree in Pharmacy Pharmaceutical Chemistry or a post-graduate degree in Chemistry with pharmaceutics as a special subject of (University established in India by the law or has an equivalent qualification recognised and notified by the Central Government for such purpose) or the Associateship Diploma of the Institution of Chemists (India) obtained by passing the examination with "Analysis of Drugs and Pharmaceuticals" as one of the subject; or)

(aa) 46b(\*\*\*)

47(b) \*\*\*

- (c) is a graduate in medicine or science of a university recognized for this purpose by the appointing authority and has had at least for one year's post-graduate training in a laboratory under (i) a Government Analyst appointed under the Act, or (ii) a Chemical Examiner, or 46b (\*\*\*)
- (iii) 47a the head of an institution specially approved for the purpose by the appointing authority:
- 48 (Provided that those Inspectors—
- (i) who have not less than 18 months experience in the manufacture of at least one of the substances specified in Schedule C, or
- (ii) who have not less than 18 months' experience in testing of at least one of the substances specified in Schedule C in a laboratory approved for this purpose by the licensing authority, or
- (iii) who have gained experience of not less than three years in the inspection of firm manufacturing any of the substances specified in Schedule C during the tenure of their service as Drugs Inspectors shall be authorised to inspect the manufacture of the substances mentioned in Schedule:

Provided further that for a period of four years from the date on which Chapter IV of the Act takes effect in the States, persons whose qualifications, training and experience are regarded by the appointing authority as affording, subject to such further training, if any, as may be considered necessary, a reasonable guarantee of adequate knowledge and competence, may be appointed as Inspectors and authorised under the preceding proviso:

49 (Provided further that any person appointed as Inspector in terms of the preceding proviso may be allowed to hold his post after the said period of four years, if the State Government is satisfied that he possesses adequate knowledge and competence as Inspector to inspect the manufacture of Items mentioned in Schedule C:)

- 50 (Provided further for the purposes of inspection of shops in any specified area any officer of the medical or public health department who is a registered medical Practitioner or a graduate in science may be appointed an ex-officio Inspector:)
- 51 (Provided further that only those Inspectors—
- (i) who are graduates in Veterinary Science or Medicine or General Science or Pharmacy and have not less than 18 months experience in the manufacture of biological product, or
- (ii) who are graduates in Veterinary Science or Medicine or General Science or Pharmacy and have had not less than 18 months experience in testing of biological product, or
- (iii) who have gained experience of not less than three years in the inspection of firms manufacturing any of the drugs specified in Schedule C during the tenure of their service as Drugs Inspectors shall be authorised to inspect the manufacture of Veterinary biological products.)
