OBITUARY.

The Government of Mizoram have learnt with deep sorrow the premature demise of Pu Zoramchhana, Sub-Divisional Officer, P.W.D., Khawzawl Sub-Division on 3.9.91 at about 1:00 A.M.

Pu Zoramchbana was born on 1.3.1953. He entered the Government service on 6.9.1975 as Overseer Grade II and promoted to the post of Junior Engineer (Civil) on 1.12.1975. He was promoted to the post of Assistant Engineer/Sub-Divisional Officer on 28.7.1986 and posted as Sub-Divisional Officer, Serchhip Sub-Division. Thereafter, he was posted as Assistant Engineer, the Office of the Chief Engineer, P.W.D., on 16.11.1988 and then he took over the charge of the Office of the Sub-Divisional Officer, P.W.D., Khawzawl Sub-Division with effect from 5.9.1990 and served there till last.

The Officer served the Government of Mizoram with utmost sincerity and devotion and he endeared himself as a conscientious Officer. The Government place on record their deep appreciation of the sincere service rendered by Pu Zoramchhana and convey their hearfelt sympathy to the bereaved family.
