NOTIFICATION

No. LRR/B.2/84/148, the 30th August, 1991. Whereas it appears to the Appropriate Government (hereinafter referred to as the "Government of Mizoram") that the land specified in the scheduled hereto (hereinafter referred to as the "said land") is likely to be needed for public purpose viz. for CONSTRUCTION OF GOVERNMENT PRESS COMPLEX.

Now, therefore, the Government hereby notifies, under sub-section (i) of Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894) (hereinafter referred to as the "said Act") that the said land is likely to be needed for the purpose specified above.

2). Any interested person on the notified land may submit written objections of claims to the Land Acquisition Collector, Aizawl within a period of 30 days from the date of publication who will dispose of the objections and claims as per provision of 5 (A) of the Land Acquisition Act.

3). All persons interested in the said land are hereby warned not to obstruct or interfere with any Surveyor or other persons employed upon the said land for the purpose of the said land of the said acquisition. Any contract for the disposal of the said land by sale, lease, mortgage, assignment, exchange, change of status of pass or otherwise or any outlay commenced or improvements made therein without the sanction of the Land Acquisition Collector, Aizawl appointed under para 5 after the date of the publication of this Notification will, under clause (seventh) of Section 24 of the said Act, be disregarded by him while assessing compensation for such parts of the said land as may be finally acquired.

4). If the Government is satisfied that the land is needed for the aforesaid purpose, a declaration to that effect under Section 6 of the said Act will be published. If the acquisition is abandoned wholly or in part, the fact will also be notified in the same manner.

5). The Government further appoints, under clause (c) of Section 3 of the said Act, the Land Acquisition Collector, Aizawl to perform the functions of a Collector under the said Act, in respect of the said land.
