## NOTIFICATION

NO. 56/91-(5).-Whereas the Election Commission of India has registered a number of associations or bodies of individual citizens of India as political parties under section 29A of the Representation of the People Act, 1951;

AND whereas, the Commission had decided, in exercise of powers under Article 324 of the Constitution of India and all other powers enabling it in that behalf, that the parties whose applications for registration under the said section 29A were pending for consideration in the Commission and which were being processed as on the 19th April, 1991, shall be deemed to be political parties registered under the said section 29A of the representation of the People Act, 1951 for the limited purpose of the General Election to Lok Sabha and General elections/by-elections to State Legislative Assemblies called by notifications issued on 19th April, 1991;

AND whereas, some of the said applications for registration have since been disposed of either by registering the parties concerned or by refusing to register them under the said section 29A of the Representation of the People Act, 1951;

AND whereas, the Commission has decided in exercise of its powers under Article 324 of the Constitution of India and all other powers enabling it in that behalf, that such of the aforesaid political parties whose applications are still

pending for consideration and are under process in the Commission for registration under the said section 29A, shall continue to be deemed to be registered political parties under the said section 29A of the Representation of the People Act, 1951, till 31st December, 1991;

NOW, therefore, in exercise of its powers under article 324 of the Constitution read with 17 and 18 of the Election Symbols (Reservation and Allotment) Order, 1968 the Election Commission hereby directs that the third paragraph of its notification No. 56/91, dated 19th April, 1991, published as O.N. 98(E) in the Gazette of India Extraordinary, Part II, Section 3(iii) dated 19th April, 1991, as amended to the extent indicated in the proceeding paragraph and further directs, in pursuance of the paragraph 17 of the said Symbols Order, that the following amendments shall be made in Table III appended to the said notification namely :-

- (i) the existing entries under column 1 and 2, at S. Nos. 35, 56, 92, 138 and 251 relating to Anttarrashtriya Abhimanyu Vichar Manch, Bharat Desham Congress, Congress for Capitalistic Oriented and other Nuhru policies, Insaf Party and Scientific Vedic Revolutionary Party respectively,
