NOTIFICATION

No. A. 12018/57/80-APT(B), the 7th November, 1991. In exercise of the powers conferred by the proviso to Art. 309 of the constitution of India, the Governor of Mizoram hereby makes the following rules to amend the Mizoram Civil Supplies Department (Group 'C' posts) Recruitment Rules, 1987 (issued under Notification No. A. 12018/57/80-APT(B) dt. 4.4.1988 and published in the Mizoram Gazette extraordinary issue No. 45(A) dt. 4.4.1988).

1. Short title and commencement 1) This rules may be called the Mizoram Food & Civil Supplies Deptt. (Group 'B' non-Gazetted and Group 'C' posts) Recruitment Rules (first amendment) Rules, 1991.
2) They shall come into force on the date of their publication in the official Gazette.

2. In the Scheduled (now annexure-I) of the Mizoram Food & Civil Supplies Deptt. (Group 'B' non-Gazetted and Group 'C' posts) Recruitment Rules, 1987 (hereinafter referred to as the said rules) for the existing entries under Col. I in respect of posts of Inspector of Civil Supplies and Sub-Inspector of Civil Supplies the following entries shall be substituted :—

1. Inspector of Food & Civil Supplies Deptt.
2. Sub-Inspector of Food & Civil Supplies Deptt.

3. In the Schedule of the annexure-I of the said rules for the existing entries under Col. 3 the following entries shall be substituted ;—

“General State Service Group 'B' non-Gazetted in respect of the posts of Inspector of Food & Civil Supplies and Group 'C' non-ministerial, non-Gazetted in respect of the posts of caretaker-cum-Liaison Officer/Transport Supervisor”.

4. In the annexure of the said Rules for the existing entry under Col. 4 the following shall be substituted.

- "1) Rs. 1640-60-2600-EB-75 2700
- 2) Rs. 1400-40-1600-50-2300-EB-60-2600".

5. In the annexure-I of the said rules against the existing entries under. Col. 7 for the post of

1) Inspector of Civil Supplies/Care-taker-cum-Liaison Officer/Transport Supervisor.

2) Sub-Inspector of Food & Civil Supplies and

3) Storekeeper the following entries shall be substituted :-

"Between 18 years and 30 years (relaxable upto 5 years for Govt. servants, belonging to Scheduled Tribe/Scheduled Castes and other backward classes".
