#### NOTIFICATION

No. K-12011/11/91-REV/4, the 25th November, 1991. Whereas it appears to the Appropriate Government (hereinafter referred to as the "Government of Mizoram) that the land specified in the scheduled hereto (hereinafter referred to as the "said land") is likely to be needed for public purpose viz. FOR ESTABLISHMENT OF LENGPUI AIRFIELD - BLOCK - I.

Now, therefore, the Government hereby notifies, under sub-section (i) of Section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) (hereinafter referred to as the "said Act") that the said land is likely to be needed for the purpose specified above.

- 2. Any person interested in any land being notified may submit their objections in writing to the Land Acquisition Collector, Aizawl within a perious of 30 days from the date of publication of Notification in the Mizoram Gazette, who will dispose of the objections and claims as per provision of 5 and 5(1) of the Land Acquisition Act.
- 3. All persons interested in the said land are hereby warned not to obstruct or interfere with any surveyor or other persons employed upon the said land for the purpose of the said land of the said acquisition. Any contract for the disposal of the said land by sale, lease, mortgage, essignment, exchange, change of status of Pass or otherwise or any outlay commenced or improvements made therein without the sanction of the Land Acquisition Collector, Aizawl.
- 4. The Government further appoints under clause (c) of Section 3 of the said Act, the Land Acquisition Collector, Aizawl to perform the functions of a Collector under the said Act, in respect of the said land.
