NOTIFICATION .

No. A. 11011/1/MCS(G), the 28th January, 1992. In exercise of the powers conferred by the proviso of Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following amendments to the rules regulating the recruitment and conditions of the service of persons appointed to the Mizoram Civil Service:—

PART - I GENERAL

- 1. Short title and commencement:
 - (i) These Rules may be called the Mizoram Civil Service (Amendment) Rules, 1992.
 - (ii) They shall come into force with effect from the date of publication in the official Gazette.
- 2. Deletion of Mizoram Civil Service (Amendment) Rules, 1988 :

The new Rules inserted in the Mizoram Civil Service (Amendment) Rules, 1988 under General Amendment the words and figures below Rule 3 of the Mizoram Civil Service Rules, 1988 shall stand deleted.

- 3. Sub-rule (2) of rule 6 of the Amendment Rules shall stand deleted.
- 4. Amendment of Rule 7:
 - Clause (a) & (b) under sub-rule (i) of Rule 7 of the Mizoram Civil Service (Amendment) Rules, 1988 the following rules shall be substituted, namely -
 - (a) 66 2/3 of the vacancies shall be filled by direct recruitment through Competitive Examination to be conducted by the Public Service Commission.

- (b) The remaining 33 1/3 of the vacancies shall be filled by selection from amongst officers who hold gazetted posts in substantive capacity in connection with the affairs of the State with not less than 5 years of service in such grade and Administrative Officer (Non-Gazetted) with not less than 8 years of service shall be eligible for consideration for induction into the service by Selection method for this quota, "in accordance with the provisions of these Rules".
- 5. Substitution of sub-rule (i) of the new Rule 9A:

For sub-rule (i) of 9A in the Mizoram Civil Service (Amendment) Rules, 41 1988 the following rule shall be substituted, namely:

9A Screening Committee:

- (i) There shall be constituted a Screening Board consisting of :-
- (a) Chairman Chief Secretary, Government of Mizoram
- (b) Members (i) To be nominated by the Government of Mizoram.
 - (ii) To be nominated by the Government of Mizora n.
- (c) Member-Secretary: Secretary to the Government of Mizoram, Department of Personnel & Administrative Reform.
- 6. Deletion of the words "Deletion of Rules 10 and Part V".

The words "Deletion of Rules 10 and Part" of the Mizoram Civil Service (Amendment) Rules, 1988 shall stand deleted and Rule 11 of Part V of the Mizoram Civil Service Rules, 1988 shall stand and the following provisions shall be substituted:

PART V - INITIAL CONSTITUTION

- 11. At the commencement of these Rules, the following persons shall be members of the Service and the past services rendered in any of the posts specified in the Schedule appended to these Rules shall be counted as service ander these Rules.
 - (i) Persons appointed under the Mizoram Civil Service Rules, 1977 as amended from time to time.
 - (ii) Persons appointed to the posts set out in Schedule 1 of these Rules till the Commencement of these Rules on the basis of competitive examination as per Government advertisement No. MAP. 17/73 dated 10. 7, 1973 and No. MAP, 47/75/2 dated 10. 1, 1976.
 - (iii) Persons not covered by sub-rule (i) and (ii) of this Rule but were holding duty posts immediately before 17th March, 1937 as defined under Rule 2(i) (c) of the Mizoram Civil Service Rules, 1977 as amended from time to time.

- (iv) Persons appointed to the posts set out in Schedule 1 of these Rules on the basis of competitive examination held as per Government advertisement No.A.12026/1/86-Pers (B) dated 22.3.1984.
- (v) Persons not covered by sub-rule (iii) of this Rule but were holding the posts set out in Schedule 1 of these Rules, including those holding temporary posts carrying the same designations specified in that Schedule and the nature of duties, status and scale of pay is identical to the Junior Grade of the Service.

Provided that no person shall be considered for inclusion under subrule (iii) and (v) of this Rule who does not qualify for appointment under the Mizoram Civil Service Rules, 1977 or the Mizoram Sub-ordinate Civil Service (Group 'B' Posts) Recruitment Rules, 1983.

. Renumbering of Rule Nos. and Part Nos. :

Part V of the amendment Rules shall be re-numbered as part VI and Part VI of the amendment Rules be re-numbered as Part VII. Rule nos. 10 and 11 of the amendment Rules shall be re-numbered as No. 12 and 13 respectively.
