NOTIFICATION DECLARATION

No. LRR/B-45/85, the 24th February, 1992. Whereas by Government. Notification Nos. (1) LRR/B-45/85 of 12.3.1990 and (2) LRR/B-45/85 of 23.10.1991 published in the Official Gazette and two daily local newspapers, it was notified under Section 4 of the Land Acquisition Act, 1894 (Central Act No. 1 of 1894) (hereinafter referred to the said Act) that the land, specified in the Schedule appended to the said Notification was likely to be needed for the public purpose namely
**for CONSTRUCTION OF BORDER
OUTPOST OF BORDER SECURITY FORCE**

And whereas the appropriate Government (hereinafter referred to as "the Government of Mizoram) after considering the report made under sub-section (2) of the Section 5 (A) of the said Act needed for the public purpose specified above.

Now therefore, the Government declares under Section 6 of the said Act that the said land is required for the public purpose specified above.

The Government also appoints, under clause (c) of Section 3 of the said Act the Land Acquisition Collector, Lunglei District to perform the functions of a Collector, Lunglei for all proceedings hereinafter to be taken in respect of the said land and directs him under Section 7 of the said Act to take order for the acquisition of the said land.

The Collector shall thereupon cause the land to be measured and make a plan of the same under Section 8 of the said Act if not already done as per Section 4 of the said Act, and dispose of all objections and claims after causing a public notice of not less than 15 days to the persons interested at convenient places on or near the land to be taken, stating the Government intention of taking over the possession of the said land as per Section 9 of the said Act. Then the Collector shall submit a Draft Award to the Government of Mizoram after fulfilling the provisions under Section 11 of the said Act.

A plan of the said land can be inspected at the Office of the Land Acquisition Collector, Lunglei District, Lunglei till the final award is made under Section 11 of the said Act.
