NOTIFICATION

No. A. 11016/1/91-DCA, the 24th February, 1992. Whereas under the provision of Section 7(1) of the Pawi-Lakher Autonomous Region (re-organisation) Order, 1972, read with the provision of para 20 B (4)(c)(e) of the Sixth Schedule to the Constitution of India, Mr. J.Tumluaia, Revenue Officer I etc. of the Pawi-Lakher Autonomous Region Saiha was allotted to the Chakma regional council by the Govt. of Mizoram vide Order No. CCMP. 3/80-82 dated 2nd April, 1972;

And whereas the Chakma District Council, under sub-section (3) of Section 6 of the Pawi Lakher Autonomous Region (Procedure and Conduct of Business) (Amendment) Act, 1954, as adopted by the Chakma District Council, appointed Mr. J.Tumluaia as Executive Secretary vide Notification No. CIE. 1/72 dated 1st July, 1972;

And whereas the Chakma District Council transferred Mr. J.Tumluaia, Executive Secretary, to Lunglei Sub-Office of Chakma District Council as Revenue Officer-cum-OSD under certain terms and conditions for a period of five years formulated by the said Council itself vide No. Nil on 14.11.1973;

And whereas the Chakma District Council violating the said terms and conditions ordered him to go down to Chawngte as Revenue Officer and not as Executive Secretary, to which Mr. J.Tumluaia would not comply with it as they violated the terms and conditions, the Council terminated his services with retrospective effect w.e.f. 1st March, 1976 when the order was issued on 15th April, 1976, without giving an opportunity, violating the provisions of the Articles 311 of the Constitution of India.

Now, therefore, after deliberate consideration of the matter, the Governor of Mizoram is pleased to re-instate Mr. J.Tumluaia in the Chakma Autonomous District Council as Revenue Officer-cum-OSD w.e.f. 1.3.1976 and posted him in the Lai Autonomous District Council Lawngtlai as Planning and Development

Officer against the post of Planning and Development Officer thereof from the date of 1st March, 1992 or from the date of his joining as such whichever is latter and the period from 1.3.1976 to 29.2.1992 or from the date of his joining as such whichever is latter shall be treated as a period spent on duty,

Further the Governor of Mizoram is pleased to order that the Chakma Autonomous District Council shall give back-wage due to him as Revenue Officer -cum-OSD under the Chakma District Council w.e.f. 1.3.1976 to 29.2.1992 or till the date of his joining as Planning and Development Officer in the Lai Autonomous District Council whichever is latter counting the period spent from 1.3.1976 to 29.2.1992 or till the date of his joining as such whichever is latter as on duty as the Revenue Officer-cum-OSD under the Chakma District Council.
