## LIST OF NOTIFIED GOODS

- 1. All Motor Vehicles, including chassis of Motor Vehicles, Motor Cycles, Motor Scooters, Motorettes/Mopeds Tractors, Bulldozer and other earth movers, spare parts and accessories thereof including tyres and tubes.
- 2. Refrigerators, Air conditioners, Water Cooling Machines, Geysers, Washing Machines and component parts thereof.
- 3. All electronic goods, instruments, apparatus, appliances.
- 4. All clocks, time pieces excluding wrist watches altimetre, ameter and all other precisions and scientific instruments.
  - 5. Iron and Steel Safes, Almirahs, furniture wooden furniture excluding local products.
  - 6. All arms including Rifles, Revolvers, Pistols, Air Rilles and Air Pistols and ammunitions for the same.
  - 7. Sound transmitting equipment including Telephones, Loud Speaker, Dictaphones Amplifier, Microphones and spare parts thereof.

Office machines and apparatus including Type-writers, Tabulating Machines, Culculating Machines, Cash Register Machines, Cheque Writing Machines, Statistical Machines, Card Punching Machines, Computers including deripheral devices, inter-com devices and component parts and accessories of such office machines and apparatus.
- 9. Binoculars, Telescope, Ópera Glass, Cameras.
- 10. Television Sets, Video Cassatte Player, V.C.R, Video Camera, Video Cassettes, Tape Recorders, Record Players, Compact Disco Player, Television Monitory, Disc Antenae and Radio Sets including component parts and accessories thereof.
