**AUGMENTATION OF TRANSMISSION SYSTEM IN SOUTH ASSAM,
MIZORAM AND TRIPURA.**

**NOTIFICATION OF THE SCHEME UNDER SECTION 29 OF THE ELEC-
TRICITY SUPPLY ACT 1948 AS AMENDED.**

Whereas in exercise of the powers under section 29 of the Electricity (Supply) Act 1948 as amended, North Eastern Electric Power Corporation Ltd. (NEEPCO) Shillong, a generating Company set up by the Govt. of India under the aforesaid Act herein referred to as generating Company with a view to meeting the growing demand for power in the N.E. Region in general and to strengthen the transmission system of South Assam, Mizoram and Tripura in particular has proposed to take up the following scheme relating to establishment, construction, erection, operation and maintenance of Transmission lines and Sub-stations/switchyards etc. with the concurrence of the Central Electricity Authority as required under section 31 read with section 29 of the Electricity (Supply) Act 1948, as amended.

NAME OF THE SCHEME :

Augmentation of Transmission system in South Assam, Mizoram and Tripura.

SALIENT FEATURES OF THE SCHEME PROPOSED

This scheme envisages the construction of following Transmission lines and Sub-Station/Switchyard.

(A) TRANSMISSION LINE :

- 1) 132 KV Single Circuit Transmission line from Khandong to Khliehriat of length 54 KMs.
- 2) Loop in Loop out of existing 132 KV single circuit Khandong-Khliehriat line at Khliehriat switching Station (NEEPCO)—length 6 KMs.
- 3) 132 KV Single Circuit Tie line connecting Badarpur Sub-Station of ASEB and the switching station of NEEPCO at Badarpur of length 5KMs.
- 4) 132 KV Single Circuit Transmission Line from Khliehriat to Badarpur switching station NEEPCO of length 110 KMs.
- 5) 132 KV Single Circuit transmission line from Badarpur Switching station to Jiribam switching station of length 60 Kms.
- 6) 132 KV Double Circuit transmission line strung single circuit from Badarpur Switching station to Kolasib Sub-station of length 100KMs.
- 7) 132 KV Single circuit line from Badarpur to Kumarghat Sub-Station of length 160 KMs.
- 8) 132 KV Single circuit transmission line from Kolasib Sub-Station to Aizawl Sub-station.

(B) SUB-STATIONS/SWITCHYARDS :

- 1) 132 KV KHLIEHRIAT SWITCHING STATION
- 2) 132 KV Badarpur Switching station.

(C) EXTENSION OF SWITCHYARD :

- 1) AT KHANDONG SUB STATION :- Extension of the existing 132 KV Khandong switching station NEEPCO by one bay.
- 2) AT BADARPUR SUB-STATION :- Extension of the existing 132 KV Badarpur switching station of ASEB by one bay.
- 3) AT JIRIBAM SUB-STATION :- Extension of the existing 132 KV switch-yard of NEEPCO by one bay.
- 4) AT KUMARGHAT SUB-STATION :- Extension of the existing 132 KV switching station of NEEPCO by 2 bays.
- 5) AT AIZAWL SUB-STATION :- Extension of existing 132 KV switch-yard of NEEPCO by 2 bays.

(D) POWER LINE CARRIER COMMUNICATION SYSTEM.**ESTIMATED COST :**

The proposed scheme of the augmentation of transmission system is estimated at Rs. 4706 lakhs.

COMMISSIONING :

The target date for completion of the scheme is 1994—95.

BENEFITS :

The Transmission line and switching stations proposed will strengthen the transmission system of South Assam, Mizoram and Tripura which will provide adequate operational flexibility and reliability in supply of power from Kopili Hydro Electric Project of NEEPCO and LOKTAK Hydro Electric Project of NHPC.

In pursuance of the provisions of the Electricity (Supply) Act 1948, the North Eastern Electric Power Corporation Ltd. shall exercise all powers vested in a generating company under the said Act for the purpose of aforesaid scheme. It is also hereby notified that in terms of sections 42 of the Electricity (Supply) Act, 1948 as amended, the North Eastern Electric Power Corporation Ltd., is undertaking and executing the sanctioned schemes, shall have all the powers for placing of any wires, poles, wall brackets, stays apparatus and appliances for the transmission and distribution of electricity or for transmission of telegraphic or telephonic communications necessary for proper co-ordination of the works of the Generating company for the areas indicated above, which the telegraphs authority possess under Part III of the Telegraphs Act. 1985 in respect of Telegraphs established or maintained and the provision of sections 12 to 16, 18, 19 of the Indian Electricity Act, 1910 shall not apply to the same.

In terms of the provisions contained in section 28 of the Electricity (Supply) Act-1948 as amended, the sanction of the aforesaid scheme by the Corporation is hereby notified to the general public by publication in the official Gazette and leading dailies.

Also, notice is hereby given inviting licensees and other persons interested who are likely to be affected by it to make representations to the Company Secretary, NEEPCO Ltd., Kharmalki Road, Dhankheti, Shillong-793001 within a period of two months with effect from the date of its publications for consideration.
