#### NOTIFICATIONS

No. H. 14011/2/92-DCA/2, the 20th March, 1992. Whereas an order for the dissolution of the Lai Autonomous District Council has been issued by the Governor of Mizoram under Notification No. C. 18011/1/91/DCA/Pt. 1 dt. 30.11.1991 and a fresh election has to be held for the purpose of Constituting a new District Council for Lai Autonomous District Council.

Now, therefore, in exercise of the powers conferred by sub-rule (2) of rule 125 of the Mizoram Autonomous District Council (Constitution and Conduct of Business of the District Councils) Rules, 1974, the Governor of Mizoram is pleased to call upon every constituency in the said Autonomous District to elect a member in accordance with the provisions of the said rules on 23rd April, 1992.

No. H. 14011/2/92-DCA/3, the 20th March, 1992. In exercise of the powers conferred by rule 132 of the Mizoram Autonomous District Council (Constitution and Conduct of Business of the District Council) Rules, 1974, the Governor of Mizoram is pleased to appoint the Deputy Commissioner, Chhimtuipui District, Saiha and the Sub-Divisional Officer (C), Lawngtlai, as a Returning Officer and an Additional Returning Officer respectively for the purpose of Elections to the Lai Autonomous District Council.

The Additional Returning Officer shall, subject to the control of the Returning Officer, exercise all the powers and discharge all the functions and duties of the Returning Officer under the said rules.

No. H. 14011/2/92-DCA/5, the 20th March, 1992. Whereas by notification No. H. 14011/2/92-DCA/3 dt. 20.3.92 issued under sub-rule (2) of Rule 125 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rule, 1974, every Constituency in the Lai Autonomous District was called upon to elect a Member for constituting of a new District Council.

Now, therefore, in exercise of the powers conferred by sub-rule (2) of rule 134 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974, the Governor of Mizoram is pleased to appoint the following dates/time with respect to the said Election :— .

1. 10th April 1992 to 14th April, 1992 (upto 12.00 noon) — Dates for filing nominations of candidates and the last date/time being on 14th April, 1992 (upto 12.00 noon).
2. 14th April, 1992 (from 12.30 P.M.)— Date/time for scrutiny of nominations.
3. 16th April, 1992 (upto 1.00 P.M.) — Last date/time for withdrawal of nominations.
4. 23rd April, 1992 (from 7.00 A.M. to 4.00 P.M.) — Date on which poll shall be taken, if necessary.
5. 27th April, 1992 — Date/time for counting of votes till completion.
6. 1st May, 1992 — Date/time for First sitting a new Council (swearing in and election of Chairman).
