## NOTIFICATION

NO.K-12011/9/92-REV, the 6th August, 1992. Whereas it appears to the Appropriate Government (hereinafter referred t) as the Government of Mizoram) that the land specified in the scheduled hereto (hereinafter referred to as the "said land") is likely to be needed for public purpose viz. TELECOM STORES AND STAFF QUARTERS.

Now therefore, the Government hereby notifies, under sub-section (i) of Section 4 of the Land Acquisition Act, 1894. (Central Act 1 of 1894) (hereinafter referred to as the "said Act") that the sand is likely to be needed for the purpose specified above.

2. Any person interested in any land being notified may submit their objections to the acquisition in writing to the Land Acquisition Collector, Aizawl within a period of 30 days from the date of publication of Notification in the Mizoram Gazette, who will dispose of the objections and claims as per provision of 5 and 5 (1) of the Land Acquisition Act.

3. All persons interested in the said land are hereby warned not to the obstruct or interfere with any Surveyor or other persons employed upon the said land for the purpose of the said land of the said acquisition. Any contract for the disposal of the said land by sale, lease, mortgage, assignment, exchange, change of status of Pass or otherwise or any outlay commenced or improvements made therein without the sanction of the Land Acquisition Collector, Aizawl appointed under para 5 below after the date of publication of this Notification will, under clause (seventh) of Section 24 of the said Act, be disregarded by him while assessing compensation for such parts of the said land as may be finally acquired.

4. If the Government is satisfied that the land is needed for the aforesaid purpose, a declaration of that effect under Section 6 of the said Act will be published in Official Gazette and in two daily newspapers and public notice thereof shall be given due course. If the acquisition is abandoned wholly or in part, the fact will also be notified in the same manner. Ex-144/92

5. The Government further appoints under clause (c) of Section 3 of the said Act, the Land Acquisition Collector, Aizawl to perform the functions of a Collector under the said Act, in respect of the said land.
