NOTICE OF ELECTION

ELECTION OF MEMBERS TO THE BAR COUNCIL OF ASSAM,

NAGALAND, MEGHALAYA, MANIPUR AND TRIPURA

Guwahati, the 3rd October, 1992.

NOTICE IS HEREBY GIVEN THAT -

1. The Election is to be held to elect 15 (fifteen) Members to the Bar Council of Assam, Nagaland, Meghalaya, Manipur and Tripura; out of which 8 (Eight) Members are to be elected from amongst the Advocates whose names have been on the State Roll for at least 10 years.
2. Forms of Nomination paper may be obtained from the Office of the Council as well as from the Offices of all Bar Associations of Assam, Nagaland, Meghalaya, Manipur and Tripura.
3. The Nomination Papers addressed to the Secretary proposed by 1 (one) Voter and seconded by another Voter (Vide Rule 8 of the Bar Council Election Rules, 1968) may be delivered to the Secretary in the office of the Council during the office hours on any date not later than the 30TH OCTOBER, 1992. Nomination paper for a Candidate must be accompanied by a fee of Rs. 200/- (Rupees Two hundred) only. The Nomination Fee is to be paid either by a Bank Draft of a Scheduled Bank having branch at Guwahati or by Cash in the Office of the Council.

4. The Nomination paper will be taken up for scrutiny at 11 A.M. on 31st. October, 1992 in the Council's office at Guwahati.
5. The Notice of withdrawal of the candidature by a candidate may be delivered to the Secretary before 4 P.M. on 6th November, 1992.
6. In the event of the election being contested, the Poll will take place on MONDAY, THE 30TH NOVEMBER, 1992 between the hours of 10 A.M. to 4 P.M. and voting by personal ballot will be held at Guwahati, Nalbari, Barpeta, Dhubri, Kokrajhat, Goalpara, Jorhat, Mangaldoi, Shillong, Nagaon, Morigaon, Golaghat, Sibsagar, Jorhat, Dibrugarh, North Lakhimpur, Tinsukia, Imphal, Silchar, Hailakandi, Karimganj, Agartala, Dharmanagar, Kailasahar, Dimapur and Kohima. At Guwahati, the election will be held at the premises of the High Court Bar Association and in rest of the Centres election will be held at the respective Bar Association premises. The Voters of the rest of the places of Assam, Nagaland, Meghalaya, Manipur, Tripura, Arunachal Pradesh and Mizoram will vote by post.
7. The voting papers despatched by post must reach the Secretary not later than the 5th December, 1992.
3. The Counting of Votes will begin at 11 A.M. on 7th December, 1992 at Guwahati.
