FUNCTION AND POWERS ETC.

- The S.A.A.B. shall function as advisory in the matter of selection of applications for house sites.
- 2. The Board shall have its sitting once in a year or more as may be required.
- 3. No TA/DA shall be given to the members of the Board.
- Applications for house sites in planned or unplanned sites shall be received in the Office of the AO/BDO/ASO concerned. After necessary verification in the usual prescribed manner, the AO/BDO/ASO concerned shall compile the statement of the applicants in seriatim with the verification report/remarks for consideration of the S.A.A.B. in market in amount

- The AO/BDO/ASO concerned as Secretary, S.A.A.B. shall notify the sitting of the Board in consultation with the Chairman by giving at least 10 (ten) days advance notice to the Board members.
- 6. In case there are more than one (1) applicant for one plot, the S.A.A.B. will recommend such names in order of priority.
- The applicants of the house sites, alongwith the minutes of the S.A.A.B. shall then be submitted to the competent authority in proper channel for necessary approval.
- The terms of the Board shall be three (3) years. The Government may however, dissolve earlier or at any time or extend as it may deem necessary in the interest of public.
