Whereas it is considered necessary to form a body under Power & Electricity Department, Government of Mizoram which is empowered to issue licence to eligible applicants, and whereas this body shall regulate the issue of such licence in line with the approved procedure for the purpose.

Now, therefore, in exercise of section 3 of Indian Electricity Act. 1910, the Governor of Mizoram is pleased to constitute Mizoram Electrical Licencing Board which shall exercise such function and duties for the purposes and within the limits of power specified below and in such manner as the Government of Mizoram may prescribe or direct :-

b) Tenure of office of the meniters of the Licencing Board other than the Chairman, Vice Chairman and Member Secretary shall be two years commencing from the date of publication in the Gazette.

Provided that where the successors of any such members has not been notified in the official Gazette on or before the expiry of the said period of two years such member shall notwithstanding the expiry of the period of his membership, continue to hold such membership until the appointment of his successors has been notified in the official Gazette.

c) The Licencing Board shall convene it sitting at least twice in one financial year, one sitting each in month of July & January. The Board members other than the Government Employee shall be entitled D.A. as the lowest Group 'A' Officer under the Government of Mizoram for the date/dates of sitting of the Board.

d) The Department's Officer entrusted to the work of Inspector shall be the Member Secretary of the Licencing Board and is a full-time member to the Board.

i) Chief Electrical Inspector (Chief Engineer : 1 No. (Power) will function as Ex-Officio CEI)

ii) Senior Inspector (the level of Executive : 1 No. Engineer)

iii) Electrical Inspector (the level of AE/SDO) : 3 Nos. : 3 Nos.

iv) Assistant Inspector (the level of Junior : 3 Nos Engineer).

v) U.D.C. 2 Nos. iv) L.D.C Cum Typist : 1 No.

This cell shall implement/carry out the decision of the Board and also place to the Board any matter connected with the Board.

2. The Licencing Board shall assist the State Government of Mizoram in discharging its duties and functions as given in Section 3, 4, 4—A, & 5 of Indian Electricity Act, 1910.

3. The Licencing Board shall function as a body to issue Electrical Licences such as Contractor Licence, Supervisor licence, Lineman Licence and Wireman Licence to the eligible and qualified applicants. And to enter, inspect and examine any place, carries or vessels if there is any reason to believe that there is any appliance or apparatus used in the generation, transmission, transformation, Conversion, distribution or use of energy.

4. The Licencing Board shall prescribe such terms as the limits within which and the conditions under which a licence shall be issued to applicants, for the approval of Government of Mizoram.
