No.D. 26014/1/94—TRP, the 25th September, 1996. Whereas the State Government of Mizoram is of the opinion that some sort of pecuniary assistance should be near as a measure of social security towards bonafide cancer patients, blind perphysically disabled and mentally retarded persons.

Now, therefore, in fulfilment of the opinion of the Government, the Governor of Mizoram is pleased to allow free travel concession in the MST Buses to bonafide cancer patients, blind persons (both eyes), physically disabled persons and mentally retarded persons in accordance with the guidelines annexed with this position which will be effective from the date of issue of this notification in the official Gazette.

This supercedes all the previous Notifications issued in this regard.

GUIDELINES FOR GRANT OF FREE TRAVEL CONCESSION TO BONA-HIDE CANCER PATIENTS, BLIND PERSONS (BOTH EYES), PHYSICALLY HISABLED PERSONS AND MENTALLY RETARDED PERSONS IN THE MIZORAM STATE TRANSPORT BUSES.

1. Cancer patients & mentally retarded persons with one accompanying attendant permanently residing in Mizoram will be allowed free trayel concession the Mizoram State Transport Buses for the purpose of Medical treatment/check up to and from the nearest MST Bus Station where they permanently reside, subject to the following conditions.

Cancer patients and mentally retarded persons shall be allowed free travel concession in the MST Buses while proceeding for medical treatment/check up returning thereafter subject to the issue of valid tickets on production of

concession card issued by the Director of Transport or by other Officers rised by him on his behalf in prescribed form at Appendix—I.

- 2. Similar concession is also allowed in the IAST Buses to blind persons (blind in both eyes) and orthopaedically disabled persons due to loss of limbs it either toth hands or both legs, permanently residing in Mizoram in town & all rural ordinary services on production of concession Card issued by the Director Transport or any other officers authorised by him on his behalf in the prescribed form at Appendix—I (A).
- 3. The concession card shall be issued by the Director of Transport or by any Officer authorised by him on his behalf after careful consideration and on receipt of applications in the prescribed form in Appendix-II from the bonafide retarded persons (both eyes)/ physically disabled persons/mentally retarded persons duly supported by Medicai Certificate.
- 4. Application form free of cost shall be available in the office of the Director of Transport or any nearest office of Station Supdt./Asstt. Station Supdt. on
- 5. The applicant should have a certificate to show that he is a cancer patient/blind persons (both eyes)/physically disabled person/mentally retarded person duly certified by the Authorised Medical Officer not below the rank of District Chief Medical Officer under his hand and seal.
- 6. Two photographs (passport size) of the applicant shall be affixed on the application duly certified by Authorised Medical Attendant not below the rank of District Chief Medical and Health Officer. Another copy of photograph shall be produced for fixing on the concession card.
- 7. The concession shall be allowed to cancer patients and mentally retarded persons when the patient proceeds for Medical treatment/check up with one accompanying attendant and the tickets shall be issued on production of the Concession Card. However, the concession for return journey will be allowed on production of Medical documents as proof of treatment/check up. New concession card may be issued on expiry of the concession card under the same terms conditions.
- 8. Loss of concession card should be reported to the Issuing Authority promptly and duplicate card shall be issued on payment of a fee of Rs. 5/- (Rupees five) only.
- 9. Change of residence of concession card holder must be promptly reported to the Issuing Authority for making necessary change in the Office record.
- 10. The Director of Transport shall maintain a Register in the proforma appended at Appendix-III.
 - 11. The Concession Card once issued shall be valid for 2 (two) years.
