NOTIFICATION

NO.LRR. 75/88-AOL-I the 20th November, 96. Whereas it appears to the Appropriate Government (hereinafter reference to as the Government of Mizoram) that the land specified in the scheduled thereto. (hereinafter referred to the "said land" is likely to be needed for public purpose viz. Acquisition of land at Uikawng Mual at Luangraual for Govt. Complex.

Now, therefore, the Government hereby notifies, under sub-section (i) of section 4 of the land Acquisition Act, 1894 (Central Act 1 of 1894) hereinafter referred to as the said land is likely to be needed for the purpose specified above.

2. Any person interested in any land being notified may submit their objection to the acquisition in writing to the Collector, Aizawl within a period of 30 days from the date of publication of this Notification in the Mizoram Gazette, who will dispose of the objections and claims as per provision of section 5 and 5 (1) of the Land Acquisition Act-1894.

All persons interested in the said land are hereby warned not to obstruct or interfere with any surveyor or other persons employed upon the said land for the purpose of the said acquisition. Any contract for the disposal of the land by sale lease, mortgage, assignment, exchange of the status of pass or otherwise or any out lay commended or improvements made therein without the sanction of the collector will, under clause (Seventh) of section 24 of the said Act, be disregarded while assessing compensation for such parts of the said land as may be finally acquired.

- 4. If the Government satisfied that the land is needed for the aforesaid purpose, a declaration to the effect that under section 6 of the said Act will be published in the Official Gazette and in two daily newspapers and public notice thereof shall be given in due course. If the acquisition is abandoned wholly or in part, the fact will also be notified in the same manner.
- 5. The Government further appoints under clause (c) of Section 3 of the said Act, the Collector Aizawl to perform the functions of the Collector under the said Act in respect of the said land.
