### Short title and commencement :

- 1) These Rules may be called the Mizoram Colleges (Provincialisation) (amendment) Rules, 1998.
- They shall come into force with effect from the date of publication in the Official Gazette.

# 2 General amendments:

- In Rule 5(2) the sentence "and/or promotion to next higher posts or grade" appearing in 4th and 5th line shall be deleted.
- in Rule 5(5) the following sentence shall be added:—
  "Provided such pay and allowances were given as per provisions of the Mizoram Aided Colleges Employees Rules, 1990 and as per University Grants Commission's norms".
- ii) In Rule 5(6) the word "sub-rule (3)" appearing in 4th line shall be substituted by "sub-rule (2)".
- iv) Rule 5(10) shall be substituted by the following:

  "(10) The post of Principal shall be filled in by appointment of the existing incumbent of the post of Principal of the Provincialised College provided he -

- 2 ..., Fulfill the conditions laid down in the sub-rule (1) of the rule,
- ii) Has been appointed in accordance with rule 4(a) of the Ma Has been appointed in accordance with rate way of the Managed College Employees Rules, 1990 as amended from time to
- iii) Has put in a minimum of ten years of regular service as Proincialisation.
