NOTIFICATION

No.A.46011/2/98-FCS, the 18th November, 1998. Whereas it is deemed expedient to set up Supplies Enforcement Squad under the Directorate of Food & Civil Supplies to curb illegal an unauthorised transportation and disposals, the Governor of Mizoram is pleased to constitute the aforesaid squad with the fellowing Officers and staff, namely:-

- 1) Deputy Director of Supplies.
- 2) Assistant Director of Supplies.
 3) 2(two) Inspectors of Food and Civil Supplies.
- 4) 1(one) Assistant for clerical works.

The functions, responsibilities and powers vested to the Supplies Enforcement Squad shall be as follows:—

- 1) The Enforcement Squad is to be attached to the General Administration Branch of Directorate of Food and Civil Supplies, Mizoram.
- 2) The Deputy Director of Supplies will coordinate Officers of the Directorate and District Food and Civil Supplies Officers in this regard.
- 3) The Squad shall check any illegal and unauthorised transportations of controlled commodities within the State of Mizoram.
- 4) The Squad shall issue seizure list for the unauthorised transportations and controlled commodities to the persons concerned.
- 5) The Squad shall supervise the Supplies Enforcement checkgates established and authorised by the Department of Food and Civil Supplies, Mizoram.
- 6) The Supplies Enforcement Squad is empowered and seize the unauthorised essential commodities at any place and any house suspected of stocking the above commodites.

- 7) The Supplies Enforcement Squad is further empowered to interrogate politely civilian and citizen who are suspected of involving in such cases.
- The Supplies Enforcement Squad is allowed to use Motor Vehicle of the Government on no vehicle day if the situation demands subject to prior approval of the Commissioner, Food & Civil Supplies.
- 9) The Supplies Enforcement Squad is authorised to check the Fair Price Shop at any time as directed by the Director, Food & Civil Supplies, Mizoram on his
- 10) Any such report pertaining to the unauthorised essential Commodities be submitted to the Director, Food and Civil Supplies who will authenticate the report for the Police Station concerned.

TERMS OF THE SQUAD:

The terms of the Supplies Enforcement Squad will be 2(two) years from the date of its publication in the Official Gazette.
