The District Fora shall function as per the provision of the said Act and the Mizoram Consumer Protection Rules, 2000 notified vide this Department's Memo No.A.52012/1/96-L&J(SCDF)/ 121 dt.1.12.2000. Further, salaries or allowances as the case may be, will be admissible to the President and Members of the District Fora as per the provision of Rule 5 of the said Rules.

Pu Lala Khobung, President, District Forum shall draw his pay and allowances against the post of Judge, Special Court under ND&PS act in his own grade pay, while Presidents of other District Fora shall draw their pay and allowances against their respective posts in their own grade pay and not as President of the District Forum.
