NOTIFICATION

No. A. 1.018/8/87-P&AR(GS), the 29th March, 2001. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the posts of Superintendent of Accounts under Transport Department, Government of Mizoram, namely :-

Short title 1. (i) These Rules may be called the Mizoram Transport Departand comment (Group 'B' posts) Recruitment Rules, 2001. mencement.

(ii) They shall come into force on the date of their publication in the Official Gazette.

The Rules shall apply to the post specified in column-I of the Annexure hereto annexed.

The number of the said post(s), their classification and the scale of pay attached thereto shall be as specified in column 2 to 4 of the Annexure -1 aforesaid.

The age limit, qualification and other matters relating to the said post shall be as specified in columns 5 to 15 of the Annexure -1 atoresaid.

Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time,
