TERMS AND CONDITIONS OF THE PLANNING AND DEVELOPMENT COMMITTEE OF THE DISTRICT COUNCIL

A. SIZE OF THE COMMITTEE: The Committee shall be headed by a Vice Chairman and should consist of 5 members (inclusive of Vice Chairman and Member Secretary). The Member Secretary should be an official of Group 'A' Category from the concerned District Council area. Composition of the Committee shall be as follows :—

1. Vice Chairman	— 1
2. Member	— 3
3. Member/Secretary	— 1 (Official)

Total	— 5

B. TENURE OF THE COMMITTEE : Tenure of the Committee shall be 3 years from the date of constitution of the Committee which should count from the date of issue of formal Notification. The members of the committee shall hold office at the pleasure of the Executive Committee of the concerned District Council.

C. STATES/ENTITLEMENT OF COMMITTEE MEMBERS :

1) Vice Chairman of the Committee shall be entitled to salary, TA/DA and all other facilities as Executive Members of the District Council.

2) Non-Official members shall be entitled to sitting allowances as prescribed by the Executive Committee and they shall be entitled to TA/DA as admissible to Group 'A' Officers (Senior Grade) for the tour performed in the discharge of their duties and functions.

D. FUNCTIONS OF THE COMMITTEE :

Functions of the Committee shall be as follows :—

1) To examine and determine the basic needs of the people of the concerned Autonomous District and to collect data for proper planning of various development programme within the powers vested with the authority of the concerned District Council.

2) To monitor and inspect various developmental projects implemented and executed by the concerned District Council.

3) To advice the Executive Committee of the concerned District Council in all matter relating to development programmes.
