TASKS

The Task Force will review and formulate the Information Technology Policy of Mizoram whose aims will be one of the largest IT contributors and strong location for software development in the country.

The Task Force will advise State Government for constitution of Working Group and Study Teams for effective implementation of Mizoram IT Policy.

The Task Force will examine the problems faced during the implementation of the Mizoram I.T. Policy and suggest remedial measures to solve such problems.

The Task Force will review and monitor the development of Infrastructure for IT Industry.

The Task Force shall meet as and when necessary but not less than thrice in a year with the approval of the Chairman.

TERMS OF REFERENCE

- Recommend a strategy for the extensive use of Information Technology in all areas of agriculture, industry, trade and commerce for making better economy of Mizoram.
- Recommend a strategy for setting up of Information Technology Park to

 attract investment in high-tech areas such as Software companies, Hardware companies, engineering consultancies, electronics and Communications Industries, etc.

- 3. Recommend a strategy, in which the use of Information Technology can be maximized in the Government at all level, so as to improve productivity and provide efficient services, transparent and accountable.
- 4. Develop a strategy for Education and Human Resource development involving government agencies, private business, voluntary organizations, educational institutions and others to multiple the number of IT professionals in the next two years.
- Develop a strategy for Mizoram as a global centre of excellence in IT education, training, and research. The task force will suggest a way to build National Institution for Information Technology.
- 6. Recommend a strategy to establish Software Technology Park with a joint effort of the Government of India, Ministry of Information Technology and Government of Mizoram to promote Software Development and Export of Software Services through Technology assessments, market analysis, marketing segmentation, marketing support, etc.
- 7. Develop a strategy for dramatically increasing the PC penetration in the state and to ensure that every household and commercial establishment that has telephone also has a computer. The strategy will aim to facilitate the availability of computer hardware, software and Internet connectivity at the lowest possible cost.
- 8. Recommend a strategy to improve and efficient Health services such as Hospital Management, Hospital-Citizen interfaces, and Telemedicine programme.
- 9. Recommend a strategy for improvement of agriculture production and marketing outlet to sale the agriculture products to the outside world.

- 10. Recommend a strategy for improvement of social and rural application to support on training, maintenance, repair services as well as awareness creation activities for Villages/ Block/ Districts level.
- 11. Suggest an appropriate legal framework for the creations of an IT-based society, with due focus on Intellectual property rights (IPR), secrecy, security and safety of information.
