NOTIFICATION

No. G. 27032/1/92-TAX/159, the 14th June, 2001. In exercise of powers conferred by sub-section (1) of section 3 of the Mizoram Sales Tax Act, 1989 (Act No. 8 of 1989) as amended from time to time, and in supersession of the Notification issued vide No. G. 27032/1/92-TAX/Pt dt.1.11.1999, the Governor of Mizoram is pleased to notify the undermensioned goods as 'notified goods' for the purpose of levying a tax at first stage of sale of such goods in the State of Mizoram with effect from 1st day of July, 2001.

LIST OF NOTIFIED GOODS

(1)	Motor vehicles, chassis of motor vehicles, motor scooters, three wheelers excluding tractors, powercillers, earthmovers, excavators.
(2)	Spare parts and accessories of motor vehicles, motor scooters, motor cycles, tyres and tubes excluding parts and accessories of tractors, powertiliers, earthmovers, excavators.
(3)	Air-Conditioners, Refrigerators, Cooling Appliances, Geysers, Televi- sions, Video Cassette Recorders, Video Cassette Player, Compact Disc/ Video Compact Disc Players, Home-Theatres, Video camera, Washing machine, Vacuum cleaners, Dish washers, Air purifiers, Voitage Stabilizer, Transformers, Photocopiers, Fax machines, Wire- less set and their parts and accessories thereof.
(4)	Computers and Information Technology products, (List of Informa- tion Technology products appended in Annexure.)

- (5) All arms including rifles, revolvers, pistol and ammunitions for the same.
- (6) Gold, Silver and other precious stones.
- (7) Building materials including cement such as Iron and Steel, Floortiles, wall-tiles of all types including ceremic, glazed tiles, mosaic tiles, marble, granite and other decorative stones slabs, white sheets, plain or corrugated sheets made of iron or other materials including asbestos, paints of all kinds lacquers distempers, cement colour, enamels, varnishes, pigments, glue, adhesive, thinner, turpentine, putty, polish and sealants.
- (8) Cosmetics and toilet goods, such as hair oil, hair cream, tooth paste, tooth powder, tooth brush, shompoo, soap of all varieties, detergents of all kind, hair-dye, scents, purfumes, cream, body and face powder, lipstick, eye-lashes, shaving sets, razors, razor-blades, shaving sticks, shaving cream, shaving brush, shaving soaps, sanitary towels, sanitary napkins.
- (9) Tinned, packed or bottled foods, cakes, biscuits, Confectioneries, drinks, butter, ghee, cream, cheese, milk food excluding locally produced/manufactured of these goods and such other goods exempted under Schedule-I.
