NOTE:

- (i) For those Specialists where there are no Specialist posted a Saha, the Board Member of that Speciality identified for Lunglei will also serve as the Board member for Saina Conveyance i A/DA for such purpose will be arranged by CMO, Lunglei.
- (ii) For those Specialists where there are no Specialists posted at Champhai & Kolasio the Board members of that Speciality identified for Aizawl will also serve as Board Member for Champhai and Kolasib.

TA/DA and conveyance/POL for such purpose will be arranged/borne by the Medical Superintendent, Civil Hospital, Alzawi.

Initially, the Boards should have meeting monthly starting from the mouth of June, 2001.

POWERS AND FUNCTIONS OF THE BOARD

Persons with Disabilities (Equal opportunities, Protection of Rights and full participation) Act, 1995 (1 of 1996) subject to the provision of this Act, the functions of the Board shall be to serve as the state local point on disability matter and facilitate the continuous evaluation of comprehensive pointy towards solving the problems faced by the persons with discounties, and enabling Persons with Disabilities to reach and maintain their optimal physical, sensory, interectual psychiatric or social functional levels.

- 1) Disability certificate shall be issued by a Medical Board duly constituted by the State Govt. (Rule Chapter 11. 4. (1)).
- 2) The Medical Board shall indicate the period of validity in the certificate, in case where there is any chance of variation in the degree of disabilities.
- 3) The Medical Board shall, after due examination give permanent Disability Certificate in cases of such permanent disabilities where there are no chances of variation in the degree of disability.

- 4) No refusal of disabilities Certificate shall be made unless an apportunity is given to the applicant of being heard.
- 5) On representation by the applicant, the Medical Board may review its decision having regard to all the facts and circumstances of the case and pass such order in the matter as it think fit.
- 6) The Certificate issued by the Medical Board under Rule 5 shall make a person eligible to apply for facilities, concession and benefits admissible under schemes of the Govt. or non Govt. organisations subject to such conditions as the Central or the state Govt. may impose.
- 7. Every application for a Certificate of Registration shall be made to the competent authority in such form and in such manner as may be prescribed by the State Govi. from time to time.
