MARCAL PARTY NOTIFICATION

No. K-15011/92/2000-REV, the 20th June, 2001. Whereas by Government Notification No. K-15011/92/2000-REV, Dt. 29.11.2000 it was notified under Section 4 of the LA Act, 1894 (hereinafter referred to as "the said Act") that, the land specified in the Schedule appended to the said Notification (hereinafter referred to as the "said land") was likely to be needed for the public purpose viz-Improvement and upgradation of Aizawl-Thenzawl-Lunglei Road via Hmuifang.

And whereas the appropriate Government (hereinafter referred to as "the Government") is satisfied after considering the report made under sub-section (2) of Section 5A of the said Act, that the said land specified in the Schedule hereto is needed to be acquired for the public purpose specified above.

Now, therefore, the Government is pleased to declare under the provision of Section 6 of the said Act that the said land is required for the public purpose specified above.

The Government also appoints, under clause (C) of Section 3 of the said Act, Pu V. Sapchhunga, Special Land Acquisition Officer, PWD to perform the functions of a Collector for all proceedings hereinafter to be taken in respect of the said land and direct him under Section 7 of the said Act to take order for the acquisition of the said land.

A Plan of the said land can be impreseld to the first of the Special Land Acquisition Officer, PWD till the award is made under Section 11.

The proposed acquisition of lands falls under Village Council jurisdiction of Melriat, Kelsih, Falkawn, Muallungthu, Tachhip, Aibawk, Szteek, Maubuang, Thiak, Sumsuih, Hmuifang, Chamring, Sialsuk, Sailam, Thenzawl and Buangpui.
