In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules relating to the recruitment to the Post of Works Manager under Transport Department.  - These Rules may be called the Mizoram Transport Department 1. Short title (i) (Group 'A' posts) Recruitment Rules, 2001. and commencement.
 - They shall come into force on the date of their publication (ii) in the Official Gazette.
 - The Rules shall apply to the post merified in column 1 2. Application. of the Annexure-I hereto annexed.
 - The number of the said post(s); their classification and the Number of 3. posts, classifica- scale of pay attached thereto shall be as specified in Columns tion & Scale 2 to 4 of the Annexure-I aforesaid. of pay.
 - The age limit, qualification and other matters relating to 4. Method of Rectt., age limit the said post, shall be as specified in columns 5 to 14 of and other the Annexure-I aforesaid. qualifications. 652

Provided that the age limit prescribed for direct recruit-ment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the C ntral Government or Government of Mizoram from time to time.

5. Disqualification.

- No person-
- (a) Who has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s):

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other grounds for doing so, exempt any such person from the operation of these rules.

- 6. Training and Every Government servant recruited under these Rules shall Departmental undergo such training or pass such Departmental Examination as may be prescribed from time to time. Examination.
- 7. Power to Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest shall have the transfer. right and power to transfer any officer so recruited under these Rules to any other post or position which is equivalent in rank or grade.
- Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons relax. to be recorded in writing in consultation with the Mizoram Public Service Commission, as the case may be through the Department of Personnel and Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.
- Reservations Nothing in these rules shall affect any reservations or other -9. and other concessions required to be provided for the Scheduled Tribes/ Scheduled Castes and other categories of persons in accorconcessions. dance with the order issued by the Central Government or Government of Mizoram from time to time in this regards.
- 10. Repeal and All Rules pertaining to these posts framed by the Govern-Savings ment of Mizoram under Notification No. A.12018/3/80-APT (B) dt. 21.11.94 and published in the Mizoram Gazette Issue No. 222 dt. 6.12.94 stand hereby repealed.

Provided that any order made or anything done or any action taken under the Rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these Rules.
