Mizoram Biotechnology Coordination Committee (MBCC) shall have powers to inspect, investigate and take punitive action in case of violations of statutory provision through the Nodal Deptt. and the State Pollution Control Board/Directorate of Health/Medical Services. The committee shall review periodically the safety and control measures in the various industries/ir stitutions handling genetically engineered organisms/Hazardous micro-organisms.
