No.LA/ESTT.70/2007 (ACP)/54, the 31st March, 2008. The Hon'ble Speaker, in exercise of the powers conferred under Rule 4 of The Mizoram Legislative Assemble Secretariat (Recruitment and Conditions of Service) Rules, 1995 as amended from time to time, is pleased to accept the Report and recommendations of the Second Report of Assembly Pay Committee, 2008 for new pay scales for the posts as shown in Appendix - 'A' of the Report in the Mizoram Legislative Assembly Secretariat.

The new pay scale shall come into force with effect from the 1st April, 2008. Initial pay in the new pay scales shall be fixed under the provision of F.R. 22(1)(a)(2) read with F.R. 23.

SECOND REPORT OF THE ASSEMBLY PAY COMMITTEE

- 1.1 The Government of Mizoram, Finance Department (PRU) vide Notification No.G.12017/3/2007 FIN (PRU) dt. 26.2.2008 issued order for new pay scales and Special Allowances for Group 'A' Officers and change of pay scales of various Group 'B', 'C' and 'D' employees under the Government of Mizoram with effect from 1.6.2007. The Hon'ble Speaker had made a decision for drawal of pay and allowances for the Officers and Staff as per new pay and allowances of their corresponding post/pay in the said Notification. The isolated posts which have no corresponding post/pay in the said Notification are placed before the Committee for its consideration and make recommendations to the Speaker as early as possible.
- 1.2 The Committee held sitting on 13.2.2008 to consider the pay and allowances of isolated posts in the Mizoram Legislative Assembly Secretariat.
- 1.3 After careful examination of the existing pay structure of isolated posts in Mizoram Legislative Assembly Secretariat, the Committee decided to recommend new pay scale for the isolated posts in the Mizoram Legislative Assembly Secretariat which have no corresponding post/pay in the said Notification.
- 1.4 The Committee therefore, recommends new pay scaled for the posts specified in the Apendix 'A' for the Mizoram Legislative Assembly Secretariat. The Committee further recommends that fixation of pay in the new scales of pay in respect of each individual case shall be done under the provision of F.R. 22 (1) (a)(2) read with F.R. 23.
