The Mizoram Appropriation (No. 1) Act, 2008

(Act No. 1 of 2008)

[Received the assent of the Governor of Mizoram on 17<sup>th</sup> March, 2008]

ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services during the Financial Years of 2002-2003 and 2003-2004.

It is enacted by the Legislative Assembly of Mizoram in the Fifty-ninth Year of the Republic of India as follows :-

| Short Title  | 1. This Act may be called the Mizoram Appropriation (No.1) Act, 2008.   |
| Issue of Rs.982,63,99,000/- out of the Consolidated Fund of the State of Mizoram for the Financial Years of 2002-2003 and 2003-2004. | 2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting, in the aggregate, to the sum of <i>Rupees nine hundred eighty two crore sixty three lakh ninety nine thousand</i> only for defraying the several charges which will come in course of payment during the Financial Years of 2002-2003 and 2003-2004 in respect of the services specified in column (2) of the Schedule. |
| Appropriation  | 3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.   |


