### NOTIFICATION

No.A. 12018/14/2003-P&AR(G3W), the 19th March, 2008. In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Mizoram is pleased to make the following rules relating to Recruitment to the post(s) of Assistant District Transport Officer under Transport Department, Government of Mizoram namely:--

1. (1) These Rules may be called the Mizoram Transport Department (Group 'B' posts) Recruitment Rules, 2008. Short title and commencement (2) They shall come into force on the date of their publication in the Official Gazette. The Rules shall apply to the posts specified in column I of the Fust Schedule hereto annexed. Applica-2. tion The number of the said post (s), their classification and the Number of 3. scale of pay attached thereto shall be as specified in column posts, classi-2 to 4 of the Annexure-I aforesaid. fication and scale of pay The age limit, qualification and other matters relating to the Method of 4. said post shall be as specified in columns 5 to 14 of the first schedule aforesaid. recruitment, age limit and other qualifications Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

Disqualifi-5. No person cation (a) Who has entered into or contracted a marriage with a person having a spouse living, or

> (b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post (s)

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of these rules.

Training 6. Every Government servant recruited under these rules shall and Departundergo such training or pass such Departmental Examination mental Exaas may be prescribed from time to time.

- Power to Notwithstanding anything contained in these Rules, the Governor 7. transfer. of Mizoram in public interest, shall have the right and power to transfer any Officers so recruited under these Rules to any other post or position which is equivalent in rank or grade.
- Power to Where the Governor is of the opinion that it is necessary or 8. expedient so to do, he may, by order and for reasons to be relax. recorded in writing in consultation with the Department of Personnel and Administrative Reforms relax any of the provisions of these Rules with respect to any class or category of persons.
- Nothing in these rules shall affect any reservations or other con-Reservations 9. cessions required to be provided for the Scheduled Castes/ and other Scheduled Tribes and other categories of persons in accordance concessions. with the orders issued by the Central Government or Government of Mizoram from time to time in this regards.
- All Rules pertaining to these posts framed by the Government Repeal & 10. of Mizorain under Notification No. STE. 17(A)77/146-149 Dt. 20.9.1980 published in the Mizoram Gazette Vol-Issue no. 40 dt. 7.11.1980 stand hereby repealed.

**Provided** that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made. done or taken under the corresponding provisions of these rules.
