SCHEDULE - II BOUNDARY DESCRIPTION OF LAWNGTLAI TOWN AREA

STARTING POINT	: The boundary starts at a point where Servate Lui intersects the National Highway-54 where B.P. No. 1 is erected.		
NORTH	: From BP No. I the boundary goes eastward upto the Phura Tlang where BP No. 2 is erected. From BP No. 2, it follows the Thingkah Lui upto a point where Thingkah Lui joints Sahri Lui where BP No. 3 is erected.		
EAST	Erom BP No. 3, it follows Sahri Lui downstream upto a point where Sahri Lui is joined by Aihniar Lui where BP No. 4 is erected. From BP No. 4, it runs upwards stream of Aihniar Lui upto a summit between Chengkawl Tlang and Sahri Tlang where BP No. 5 is erected. From BP No.5, it runs downwards following Thangpui upto a point where Thanglui joined Tuipui river where BP No. 6 is erected. From BP No. 6, it follows the Tuipui river upto a point where Tuipui Lui is joined by Saikah Lui, where BP No. 7 is erected.		
SOUTH	: From BP No. 7, it follows Saikah Lui upwards upto a point where it intersects the National Highway-54 where BP No. 8 is erected. From BP No. 8, it follows the National Highway - 54 upto a point where it is intersected by Mualkawi Lui where BP No. 9 is erected. From BP No. 9, it follows Mualkawi Lui upto a point where Mualkawi Lui is joined by Tuiphah Lui where BP. No. 10 is erected.		
WEST	: From BP No. 10, it follows Tuiphah Lui upwards upto Tuiphah-peng where BP No. 11 is erected. From Bp No. 11, it follows Servapui Lui downwards upto a point where it is joined by Servate Lui where BP No. 12 is erected. From BP. No. 12, it follows Servate Lui upwards upto the National Highway - 54 where BP No. 1 is erected.
