No.A. 12018/35/2003 - P&AR(GSW), the 10th November, 2008. In exercise of the powers conferred by the proviso to Article 313 of the Constitution of India, the Governor of Mizoram is pleased to make the following Regulation relating to the recruitment to the post of Deputy Controller of Examinations under Mizoram Public Service Commission, namely :-

| <i>Short title and commencement</i> | 1 | (1) These Regulations may be called the Mizoram Public Service Commission (Group 'A' posts) Recruitment Regulations, 2008.
(2) They shall come into force from the date of their publication in the Official Gazette. |
| <i>Application</i> | 2 | These Regulations shall apply to the post(s) specified in Column - I of the First Schedule hereto annexed. |
| <i>Number of posts classification and scale of pay</i> | 3 | The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2, 4 & 5 of the First Schedule |
| <i>Method of recruitment age limit and other qualifications.</i> | 4 | The age limit, qualifications and other matters relating to the said posts shall be as specified in Columns 6 to 14 of the First Schedule. Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time. |

- Disqualification* 5 No person -
- (a) Who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post; Provided that the Commission may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of these Regulations.
- Training and Departmental Examination* 6 Every Officer shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
- Power to relax* 7 Where the Commission is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax any of the provisions of these Regulations with respect to any class or category of persons.
- Reservation, other Concessions* 8 Nothing in this Regulations shall affect reservation and other concessions required to be provided for the Scheduled Caste, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Government of Mizoram from time to time in this regard.
