## THE JERC ADAPTATION OF LAWS AND ORDER 2008

No.A.12011/3/08-JERC/15, the 30<sup>th</sup> October, 2008. In exercise of powers conferred by Regulation 21 of JERC (Recruitment, Control and Service Conditions of Officers and Staff) Regulations, 2008 which was duly approved by the Central Government as appropriate Government under Section 91(3) of the Electricity Act, 2003, the Joint Electricity Regulatory Commission for the States of Manipur and Mizoram hereby adapts the Central Civil Services (Conduct) Rules, 1964 and the Central Services (Control, Classification and Appeal) Rules, 1965.

- 1. a) This order may be called the Joint Electricity Regulatory Commission for Manipur and Mizoram Adaptation of Laws (Disciplinary Proceedings & Imposition of Penalties) 1st Order, 2008.
  - b) It shall be deemed to have come into force on the 3rd day of March, 2008.
- 2. In this order :
  - a) "Appointed Day" means the 3rd day of March, 2008.
  - b) "Act" means the Electricity Act, 2003.
  - c) "Central Government" means Ministry of Power in Union of India and includes other Ministries/Departments in the Union of India.
  - d) "Appointing Authority" means
    - (i) Chairperson, in respect of all posts from Sl.No. 1 to 8 of Regulation 4 of Service Regulations for Officers and Staff of the Commission.
    - (ii) Secretary, in respect of all posts from Sl.No. 9 to 14 of Regulation 4 of Service Regulations for Officers and Staff of the Commission.
    - (iii) Assistant Secretary, in respect of all other posts.

- e) "Chairperson" means the Chairperson of the Commission.
- f) "Commission" means the Joint Electricity Regulatory Commission for the States of Manipur and Mizoram.
- g) "Disciplinary Authority" means-
  - (i) Chairperson, in respect of all posts from Sl.No. 1 to 8 of Regulation 4 of Service Regulations for Officers and Staff of the Commission.
  - (ii) Secretary, in respect of all posts from Sl.No. 9 to 14 of Regulation 4 of Service Regulations for Officers and Staff of the Commission.
  - (iii) Assistant Secretary, in respect of all other posts.
- h) "Function" means and includes all works related to activities of the Commission.
- i) "Member" means a Member of the Commission.
- j) "Staff" includes both officers and employees of all categories appointed whether on deputation on foreign service terms or permanent absorption or on short-term contract basis or direct recruitment or promotion.
- 3. As from the appointed day, the provisions of this Order and the Central Civil Services (Conduct) Rules 1964, and the Central Civil Services (Control, Classification and Appeal) Rules, 1965 and the instructions issued by the Government of India thereunder from time to time shall until altered, repealed or amended by a competent authority, have effect, subject to modification as Regulation 2(d) and (g) above.
