JOINT ELECTRICITY REGULATORY COMMISSION FOR MANIPUR AND MIZORAM, AIZAWL

Terms and Conditions for Determination of Tariff

NOTIFICATION

No. A. 45016/1/08-JERC, the 19th January, 2009. In exercise of the powers conferred under section 181 and all other powers enabling it in this behalf and after previous publication, the Joint Electricity Regulatory Commission for Manipur and Mizoram (JERC M&M) makes the following regulations to amend the Joint Electricity Regulatory Commission for Manipur and Mizoram (Terms and Conditions for Determination of Tariff) Regulations, 2008, hereinafter referred to as "The principal regulations" namely:

1. Short title and commencement

- (1) These regulations may be called the Joint Electricity Regulatory Commission for Manipur and Mizoram (Terms and Conditions for Determination of Tariff) (First Amendment) Regulations, 2009.
- (2) These regulations shall come into force from the date of publication in the official gazette.

2. Amendment of Regulation 42

Regulation 42 of the principal regulation shall be substituted as under, namely: "42.0 Charges for Unscheduled Interchange (UI):

42.1 Variation between actual generation or actual drawal and scheduled generation or scheduled drawal shall be accounted for through Unscheduled Interchange (UI) Charges. UI for a generating station shall be equal to its actual generation minus its scheduled generation. UI for a beneficiary shall be equal to its actual drawal minus its total scheduled drawal. UI shall be worked out for each 15 - minute time block.

Charges for all UI transactions shall be based on average frequency of the time block and the following rates shall apply:

(Each 0.02 Hz step is equivalent to 8.0 Paise/kWh in the 50.5 - 49.8 Hz frequency range to 18.0 paise/kWh in the 49.8 - 49.0 Hz frequency range.)

3. Amendment of Regulation 61

Clause 61.1 of Regulation 61 of the principal regulation shall be substituted as under, namely:-

61.1 Variation between actual generation or actual drawal and scheduled generation or scheduled drawal shall be accounted for through Unscheduled Interchange (UI) Charges. UI for a generating station shall be equal to its actual generation minus its scheduled generation. UI for a beneficiary shall be equal to its total actual drawal minus its total scheduled drawal. UI shall be worked out for each 15 - minute time block.

Charges for all UI transactions shall be based on average frequency of the time block and the following rates shall apply:

4. Amendment of Regulation 98

Clause (b)(2) of Regulation 98 of the principal regulation shall be substituted as under, namely:-

"Interest and finance charges on loan capital for new investments shall be computed on the loans, duly taking into account the rate of interest and the schedule of repayment as per the terms and conditions of relevant agreements. The rate of interest shall, however, be restricted to the prevailing Prime Lending Rate of the State Bank of India".
