THE APPROPRIATION (No. 4) ACT, 2008

ACT

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of India for the services of the financial year 2008-09.

BE it enacted by Parliament in the Fifty-ninth Year of the Republic of India as follows:-

l. This Act may be called the Appropriation (No. 4) Act, 2008.

Short title. Issue of Rs.

2. From and out of the Consolidated Fund of India there may be paid and applied sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate 55604,83,00,000 to the sum of fifty-five thousand six hundred and four crores, and eighty-three lakh rupees towards defraying the several charges which will come in course of payment during the for the financial financial year 2008-09 in respect of the services specified in column 2 of the Schedule.

The sums authorised to be paid and applied from and out of the Consolidated Fund Appropriation. of India by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
