No.H.12018/83/2009-LJD 6, the 7th April, 2009. The following Act of the Mizoram Legislative Assembly, which received the assent of the Governor of Mizoram is hereby published for general information.

The Mizo Appropriation (No. 2) Act, 2009.

(Act No. 2 of 2009).

[Received the assent of the Governor of Mizoram on the 27th March, 2009]

THE MIZORAM APPROPRIATION (No. 2) ACT, 2009 AN ACT

to authorise payment and apropriation of certain sums from and out of the Consolidated Fund of the State for the services for the first four months of the Financial Year, 2009-2010 (i.e. April to July, 2009).

It is enacted by the Legisalative Assembly of Mizoram in the Sixtieth Year of the Republic of India as follows :-

Short Title

Issue of **Rs.1068,96,89,000/-** out of the Consolidated Fund of the State of Mizoram for the first four months of the Financial Year 2009-2010 (i.e. April to July, 2009)

Appropriation

1. This Act may be called the Mizoram Appropriation (2) Act, 2009.

2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting, in the aggregate, to the sum of Rupees One thousand sixty eight crore ninety six lakh eighty nine thousand only for defraying the serveral charges which will come in course of payment for the first four months of the Financial Year, 2009-2010 (i.e. April to July, 2009) in respect of the services specified in column (2) of the Schedule.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
