#### **SCHEDULED - II**

### DESCRIPTION OF RUNNING BOUNDARY ON THE MAP OF THENZAWL TOWN PLANNING AREA

The Planning area for Thenzawl consist the area within the following limit.

#### BOUNDARY DESCRIPTION OF THENZAWL TOWN

Starting Point:

The boundary Pillar No. 1 has been fixed near the confluence of small river and river Vanva on the North-Western part of Thenzawl town at a point of 92°45'17: E Longitude and 23°18'18" N. Latitude. This point is used as a starting point for Thenzawl town boundary.

North:

From the starting point the boundary line turns North-East direction follows the streams which comes from the River Vanva and Pillar No. 2 is fixed at the top of the hillock on a point of 92°46′5″ E Longitude and 23°18′27″ N. Latitude. From this the boundary line still runs on North-East direction and on the hillock Pillar No. 3 is fixed. This point is 92°46′25″ E Longitude and 23°18′32″ N. Latitude. From Pillar No. 3 the boundary line follows a stream on eastern direction and at the confluence of small streams with River Vawmdelh on a point of 92°46′43″ E Longitude and 23°18′32″ N. Latitude a boundary Pillar No. 4 is fixed. From this point the boundary line runs along Vawmdelh River and near the confluence with River Lau Pillar No. 5 is fixed which is a point of 92°47′7″ E. Longitude and 23°18′24″ N. Latitude.

East:

From Piller No. 5 the boundary line follow Lau River and at a point where it meets with small stream piller No. 6. is fixed. This point is 92°46′57" E Longitude and 23°18′00" N Latitude. From this the boundary follow Lau River on Southward direction and then reaches Serchhip to Thenzawl road on the eastern side from River Lau where pillar No. 7 is fixed on the road side. This point is 92°17′4" E Longitude and 23°17′40" N Latitude. The boundary line runs on southwards direction till it reaches the adjoining place of a small stream with Lau River at a point of 92°47′18" E Longitude and 23°17′19" N Latitude. Where pillar No. 8 is fixed. From Pillar No. 8 the boundary line runs on south east direction passing the flank of the mountain upto the top of the hillock at a point of 92°47′35" E

Longitude and 23°17'00" N Latitude in which pillar No. 9 is placed. The boundary lines then runs on southward direction toward the tributary of Lay river on the south eastern part from Thenzawl near the source of the tributary at a point of 92°47'33" E Longitude and 23°16'30" N Latitude. Where Pillar No. 10 is fixed. From this the 7 boundary line still then runs on south direction and Pillar No. 11 is placed near the small stream adjacent to source/rise of the Tuikhur river. This point is 92°47'30" E Longitude and 23°16'9" N. Latitude.

South:

The boundary line then follow Tuikhur river south east direction towards the confluence of the Tuikhur river and a small stream near Zote road that crosses Tuikhur river. There, Piller No. 12 is fixed which is at a point of 92°46′55" E Longitude and 23°15′56" N Latitude. From piller No. 12 the boundary line proceeds in the same direction along the Tuikhur River and at a point of 92°46′30" E Longitude and 23°15′56" N Latitude at a spire of Tuikhur River, Piller No. 13 is fixed. From Piller No. 13 the boundary follow Tuikhur river towards south east direction. At the point of 92°46′00' E Longitude and 23°15′32' N latitude after crossing Midang river where it intersect with Thenzawl- Lunglei road Piller No. 14 is fixed nearby the road side. From this the boundary line runs straight on east direction and at a point of 92°45′56' E Longitude and 23°15′29' N Latitude. Where it crosses a small stream Piller No. 15 is placed. From this the boundary line runs on east direction and at a place where it meet with Vanva river at a point of 92°44′45" E Longitude and 23°15′30' N Latitude Piller No. 15. is fixed.

West:

The western side boundary line follow Vanva river on north direction and near the confluence of the small river with river Vanva Piller No. 17 is fixed. This point is 92°44'51" E Longitude and 23°15'58" N Latitude. From Piller No. 17 still follows towards the source/headwater of the Vanya river on Northwards direction and Piller No. 18 is fixed at a place where Vanva river meets with a small river. This point is 02°44'51" E Longitude and 23° 16'18" N Latitude from this the boundary line runs northern direction along the river Vanva and at a place where it meets with Thenzawl - Buarpui road Piller No. 19 is fixed. This point is 92°44'51" E Longitude and 23°16'36" N Latitude. Then the boundary proceed on north direction along the river Vanva and at the Confluence with a small streams that comes from Vengthar Pillar No. 20 is fixed which is a point of 92°45'00" E Longitude and 23°17'6" N. Latitude. From this it runs in the same direction along the river Vanva and Pillar No. 21 is fixed at the Confluence of Vanva river and a stream which comes from the side of Cementary. This point is 92°45'77" E Longitude and 23°17'44" N Latitude. From Piller No. 21 the boundary line proceed in the same direction following river Vanva and meet the Piller No. 1 which is used as starting point as mentioned in the first para.
