NOTIFICATION

No.A.12018/10/2003-P&AR(GSW), the 18th August, 2009. In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following Rules relating to the post(s) of Surveyor - I and Surveyor under Land Revenue & Settlement Department, Government of Mizoram, namely:-

Short title and commencement

Application

Number of posts Classification and scale of pay

Method of recruitment, age limit and other qualification

Disqualification

- 1. (1) These rusles may be called the Mizoram Land Revenue & Settlement Department (Group 'B' post) Recruitment Rules, 2009.
 - (2) They shall come into force from the date of publication in the Official Gazette.
- 2. These Rules shall apply to the post(s) specified in column I of the Annexure-I hereto annexed.
- 3. The number of the said post(s), their classification and the scale of pay attached thereto shall be as specified in Column 2 to 4 of the Annexure-I.
- 4. The age limit, qualification and other matters relating to the said post, shall be as specified in Column 5 to 14 of the Annexure-I aforesaid.
- 5. No person-
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s)

		Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of these rules.
Training and Departmental Examination	6.	Every Government servant recruited under these rules shall undergo such training or pass such Departmental Examina- tion as may be prescribed from time to time.
Power to transfer	7.	Notwithstanding anything contained in these Rules, the Governor of Mizoram in public interest, shall have the right and power to transfer any officer or official, so recruited un- der these Rules to any other post or position which is equiva- lent in rank or grade.
Power to relax	8.	Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing in consultation with the Mizoram Public Service Commission through Department of Personnel & Ad- ministrative Reforms relax any of the provisions of these rules with respect of any class or category of persons.
Reservation and other concessions	9.	Nothing in these rules shall affect any reservations and other concession required to be provided for the Schedules Castes/ Scheduled Tribes and other categories of persons in accor- dance with the orders issued by the Central Government or Government of Mizoram from time to time in this regard.
Repeal & Saving	10.	All Rules pertaining to these posts framed by the Governor of Mizoram under Notification No.A.12018/10/2003- P&AR(GSW) dt. 16.12.2003 as published in the Mizoram Gazette Extra Ordinary Issue No. 345 dated 29.12.2003 in re- spect of Surveyor - I and Notification No. REV 6/79/189 dt.12.11.1980 and No.A.12018/39/80-APT(B) dt. 14.06.1985 in respect of Surveyor - II published in the Mizoram Gazette Extra ordinary Issue No. 23 dt. 14.06.1985 stand repealed.
		Provided that any order made or anything done or any action taken under the rules so repealed, or under any general order ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
