## **NOTIFICATION**

No.A. 12018/44/2004 - P&AR(GSW)/Pt, the 11<sup>th</sup> May, 2010. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following Rules relating to the recruitment to the post(s) of Joint Director of Industries/General Manager DICs under Industries Department, Government of Mizoram namely :-

Short title and commencement	1.	<ol> <li>These rules may be called the Mizoram Industries Department (Group 'A' posts) Recruitment Rules, 2010.</li> <li>They shall come into force on the date of their publication in the Official Gazette.</li> </ol>
Application	2.	These rules shall apply to the posts specified in Column I of the Schedule annexed to these rules.
Number of posts, classification and scale of pay	3.	The number of the said post(s), their classification and the scale of pay attached thereto shall be as specified in Column 2 to 4 of the said Schedule.
Method of recruitment, age limit and other qualification.	4.	The method of recruitment of the said posts, age limit, qualifications and other matters relating to the said post shall be as specified in Column 5 to 14 of the aforesaid Schedule.
Disqualification	5.	<ul> <li>No person -</li> <li>(a) Who has entered into or contracted a marriage with a person having a spouse living; or</li> <li>(b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s);</li> </ul>
Training and Departmental Examination	6.	Every Government servant recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
Power of transfer	7.	Notwithstanding anything contained in these Rules, the Governor of Mizoram, in public interest, shall have the right and power to transfer any officers, so recruited under these Rules to any other post or position which is equivalent in rank or grade.

Where the Governor is of the opinion that it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing in consultation with the Department of Personnel & Administrative Reforms relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect any reservations, realxation of age limit and other concessions required to be provided for the Scheduled Castes/ the Scheduled Tribes and other categories of persons in accordance with the order issued by Central Government or Government of Mizoram from time to time in this regards.

All rules pertaining to these posts under Industries Department framed by the Government of Mizoram vide Notification No. A. 12018/74/80-APT(B); Dt. 17.04.1986 issue No. 27 dt. 17.04.1986 in respect of the post of General Manager, DIC, and even No. Dt. 28.03.1990 issue No. 35 dt. 28.05.1990 in respect of the post of Joint Director and even No. Dt. 20.10.1988 issue No. 117 (D) dt. 20.10.1988 in respect of the post of General Manager, DIC, are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general order ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions at these rules.
