**THE MIZORAM APPROPRIATION (No. 1) ACT, 2015**

**ACT No. 1 OF 2015**

**AN  
ACT**

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services during the Financial Years of 2010-2011 and 2011-2012.

It is enacted by the Legislative Assembly of Mizoram in the Sixty Sixth Year of the Republic of India as follows, namely

| <b>Short title</b>  | 1. This Act may be called the Mizoram Appropriation (No. 1) Act, 2015   |
| <b>Issue of ` 52873000/- only out of the Consolidated Fund of the State of Mizoram for the Financial Years 2010-2011 and 2011-2012.</b> | 2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting, in the aggregate, to the sum of <b>Rupees five crore twenty-eight lakh seventy-three thousand</b> only for defraying the several charges which will come in course of payment during the Financial Years of 2010-2011 and 2011-2012 in respect of the services specified in column (2) of the Schedule. |
| <b>Appropriation</b>  | 3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.   |
