The Mizoram Act No 4 of 1976.

(The Appropriation (No 2) Act, 1976)

Received the assent of the Administrator on the 31st March, 1976.

AN ACT

to provide for the withdrawal of certain sums from and out of the Consolidated Fund of Mizoram to the Services for the period from 1st April, 1976 to 31st March, 1977.

Be it enacted by the Legislative Assembly of Mizoram in the Twenty seventh year of the Republic of India as follows:—

1. This Act may be called the Appropriation (No. 2) Act, 1976

Short title.

2. From and out of the Consolidated Fund of the Union Territory Authorisation of of Mizoram there may be paid and applied sums not exceeding appropriation of those specified in column 3 of the Schedule amounting to the sum of Rs. 42,89,20,000/-Rupees fortytwo crores eightynine lakhs, and twent thousand only from and out of towards defraying several charges which will come in the consolidated ment during the financial year 1976--77 in respect the services Fund of the specified in column 2 of the Schedule.

Union Territory of Mizoram for

the Financial Year 1976-77.

3. The sums authorised to be paid and applied from and out of the Appropriation. Consolidated Fund of the Union Territory of Mizoram by the Act shall be appropriated for the services and purposes expressed in the schedule in relation to the period from 1.4.76 to 31.3.77.
