## NOTIFICATION

No. ESS. 350/74/40, the 3rd May, 1976. The Lt. Governor (Administrator) of Mizoram is pleased to make Rules for non-Recurring Grants-in-aid to recognised Institutions in Mizoram, as approved by Government of India, Ministry of Education and Social Welfare, (Department of Education), New Delhi, vide their letter No. F. 48-147/74-UT I/II dated 25th March, 1976 with the concurrence of Ministry of Finance vide their U.O. No. 3295-Edu. Unit/76 dated 17th March, 1976.

1. PREAMBLE ; Whereas the Government deems it expedient to extend adequate assistance within the limit of its financial resources in the shape of recurring and/or non-recurring grants-in-aid to deserving educational institutions in Mizoram ;

Now that the Lt. Governor of Mizoram, in the exercise of powers conferred upon him under Rule 12 of the D.F.P. Rules 1958 (as amended) is pleased to frame the following rules to regulate such grant-in-aid to educational institutions in Mizoram.

2. **SHORT TITLE :** These Rules may be called "NON-RECURRING GRANTS-IN-AID RULES FOR THE RECOGNISED EDUCATIONAL INSTITUTIONS IN MIZORAM."

3. **DEFINITIONS :** In these Rules, unless the context requires otherwise.

- (i) "Administrator" means the Lt. Governor of Mizoram.
- (ii) "Government" means the Government of Mizoram.
- (iii) "Department" means the Department of Education & Social Welfare; the "Directorate" means the Directorate of Education and Social Welfare.
- (iv) "Director" means the Director of Education & Social Welfare, Mizoram.
- (v) "Inspector" means the Inspector of Schools, Mizoram and includes for the purpose of these rules Assistant and Deputy Inspectors of Schools, Mizoram.
- (vi) "Institution" means any educational institution in Mizoram recognised by the Government.
- (vii) "Committee" means the Managing Committee/Governing Body of an Institution duly constituted and approved by the Government.
- (viii) "Chairman" means the Chairman of a Managing Committee/Governing Body.
- (ix) "Treasurer" means any one member of the Committee/Governing Body declared to hold the office by a voted resolution of the Committee.
- (x) "Secretary" means the Secretary of the Committee.
- (xi) "Grants" means non-recurring grant-in-aid and includes all financial assistance given on this account to an institution in cash and/or in kind.
- (xii) "Board" means a Board of Education/Examination to which an institution is affiliated for the purpose of any public examination conducted by the affiliating Board.
- (xiii) "Affiliating University" means a University to which a college in Mizoram is affiliated for the purpose of the various examinations conducted by the University.

**4. SCOPE AND COMMENCEMENT:** These Rules shall apply to institutions in Mizoram in the manner and to the extent stipulated in the various sections and sub-sections of these Rules and shall come into force with effect from such date as the Government may, by notification in the official Gazette of Mizoram, publish.

**5. CATEGORIES OF GRANTS:** There shall be the following categories of non-recurring grants-in-aid to recognised institutions in Mizoram. 5(1) Grants for constructions/renovation involving major addition and alterations/special repairs involving heavy expenditure and/or purchase of:—

- (a) Institution buildings,
- (b) Hostel buildings,
- (c) Staff quarters,
- (d) Play fields, open air gymnesia, auditorium etc.
- (e) Permanent fencing for protection against cattle nuisance etc.
- (f) Water-reservoir for drinking water

**5 (2) Other admissible non-recurring grants:**

- (a) For class-room, common room, laboratory and library, Hostel furniture & fittings
- (b) For purchase of libraries' books, teaching aids including Science equipments, raw-materials for craft classes, sports & physical education equipments, utensils, tools & equipments for work-experience, games
- (c) For conducting sports drama and other competitions
- (d) For educational tours and excursions, scouts & guides camps
- (e) For conducting seminars and/or short-term course on methods of teaching and contents etc. of so entrusted by Director of Education.
- (f) For school uniforms to poor and deserving students and uniform for scouts & scouters, guides and guiders
- (g) For other co-curricular activities which may be considered conclusive to the educational growth of the students.

## 6. ELIGIBILITY AND CONDITIONS :

6(1) Any recognised institutions in Mizoram may be considered for non-recurring grants-in-aid if the Government feel satisfied that by extending much financial assistance to the institution, the growth and development of education in Mizoram shall be accelerated. No grant shall, however, be given unless the institution is run by a duly constituted Managing Committee/Governing Body which holds the ownership of the institution on a legally valid basis and the members of the Managing Committee/Governing Body bind themselves severally and individually to utilise the grants provided, for the purpose for which it is made and ensure that any immovable assets acquired out of the grant are not disposed off without prior approval of the Government and in case such approval for their disposal is secured, to utilise the proceeds thereof only in the way approved by the Government.

6 (2) An institution approaching the Government for any non-recurring grants-in-aid under Rule 5(1) shall make an application to the Director of Education through the Inspector of Schools concerned. The application must be accompanied with the plan and estimate prepared on the basis of current P.W.D. schedule of rates and duly certified by a P.W.D. Executive Engineer in case the estimate is beyond Rs. 50,000/- by a P.W.D., S.D.O. if the estimate is over Rs. 10,000/- but below Rs. 50,000/- and by a P.W.D. Overseer if it is below Rs. 10,000/-

6 (3) No grants-in-aid to any recognised institutions shall normally be given for any of the items under Rule 5(1) beyond the limit of  $\frac{2}{3}$  of the certified estimate as required under Rule 6(2). The balance amount needed for completing the work according to the certified estimate shall have to be found by the Managing Committee/Governing Body in cash and/or in kind and shall be accepted as the share of matching contribution of the Managing Committee/Governing Body against the grants-in-aid made by the Government. The Managing Committee, shall, however, produce a certificate on their behalf that they undertake to complete the work as per certified plan and estimate with the amount of grant received from the Government plus their own contributions.

6 (4) Subject to the limit of  $\frac{2}{3}$  of the certified estimate as prepared on the basis indicated in 6(2) the grant may be released in one or more instalments according to availability of funds and actual progress of work.

6 (5) No grants-in-aid for construction/special repair etc. for any item of work under Rule 5(1) shall be made unless the Managing Committee have already acquired adequate land, with its ownership legally vested in the Managing Committee.

6 (6) The ceiling of grants-in-aid for the various items under Rule 5(1) shall be as under :—

6 (7) Second or subsequent instalment of non-recurring building grants shall not be released unless the Managing Committee furnishes full utilisation certificate for the entire amount of non-recurring grants already received together with a detailed statement of accounts and reasonability certificate from a qualified P.W.D. Officer.

6 (8) For all non-recurring grants-in-aid received by a managing Committee for its institution, a separate account shall be maintained in G.F.R. Form No. 20 and expenditure from this account shall be strictly restricted to that for which the grant has been received.

6 (9) Non-recurring grants-in-aid may be given to a non-Government recognised Institution in Mizoram for any one or more of the purposes indicated under Rule 5 (2) subject to availability of funds. These grants shall be of an adhoc nature shall be given by the Government to deserving institution in Mizoram on the recommendation of the Director of Education, subject further to the condition that the total non-recurring grants-in-aid for one or more of the purposes under Rule 5 (2) during one financial year shall not exceed Rs. 15,000/- in case of a college, Rs. 10,000/- in case of High School ; Rs. 5,000/- in case of M.E. School and Rs. 2,000/- in case of a L.P. School.

#### 7. SANCTIONING AUTHORITY :

7 (1) The Government shall be the competent authority to sanction any grant under these Rules.

7 (2) The Government may, if it considers necessary delegate this power to the extent deemed appropriate any of its subordinate authorities.

8. The Government reserves the right of adding to or altering these rules provided that such additions and alterations shall not be permissible in respect of the rules fixing the quantum of grants—without prior approval of the Government of India.

Governor (Administrator) of Mizoram is pleased to make "Merit Scholarship Rules for Primary and Middle School Leaving Examination in Mizoram", as approved by Government of India, Ministry of Education and Social Welfare, (Department of Education) New Delhi, vide their letter No. F. 48—157/74—UT I/UT 2 dated 6th April, 1976 with the concurrence of Ministry of Finance vide their U.O. No. 12835/Edu. Unit/75 dated 28 November 1975.

1. **PREAMBLE:** Whereas the Government of Mizoram deems it expedient to generate local competence by encouraging talented students to continue their studies un hampered due to financial constraints ;

and

Whereas for this purpose the Government deems it necessary to institute suitable number of Merit Scholarship for such talented students at Middle and High School stage of their career in schools ;

Now that the Lt. Governor of Mizoram, in the exercise of powers conferred upon him under Rule 12 of the D.F.P. Rules 1958 (as amended) is pleased to frame the following rules to regulate such Merit Scholarship in Mizoram.

2. **SHORT TITLE:** These Rules may be called "MERIT SCHOLARSHIP RULES FOR PRIMARY AND MIDDLE SCHOOLS LEAVING EXAMINATION IN MIZORAM."

3. **DEFINITIONS:** In these Rules, unless the context requires otherwise.

- (i) "Administrator" means the Lt. Governor of Mizoram.
- (ii) "Government" means the Government of Mizoram.
- (iii) "Department" means the Department of Education & Social Welfare ; the "Directorate" means the Directorate of Education and Social Welfare, Mizoram.
- (iv) "Director" means the Director of Education & Social Welfare, Mizoram.
- (v) "Inspector" means the Inspector of Schools, Mizoram.
- (vi) "Deputy Inspector of School" means the Deputy Inspector of School, Mizoram.

- (vii) "Institution" means any educational institution in Mizoram recognised by the Government.
- (viii) "Examination" means an examination held by the Director or any Agency authorised by him or a Board constituted by the Government at the close of Primary and Middle School Stages of Education.

4. **SCOPE AND COMMENCEMENT:** These Rules shall apply to institutions in Mizoram in the manner and to the extent stipulated in the various sections and sub-sections of these Rules and shall come into force with effect from such date as the Government may, by notification in the official Gazette of Mizoram, publish.

5. **CATEGORIES OF SCHOLARSHIPS:** For the purpose of these Rules, there shall be the following categories of Scholarships:

- (a) Primary School Leaving Merit Scholarships,  
 (b) Middle School Leaving Merit Scholarships.

These Merit Scholarships shall be awarded to bonafide students of Mizoram on the result of examination held at the close of the Primary and Middle School stages provided that for determining such Merit, examinees from various Districts and District Councils of Mizoram shall be considered separately.

6. **NUMBER, VALUE AND DURATION OF THESE SCHOLARSHIPS:**

The numbers of these Scholarships shall be as indicated in the Statement below which also indicates Districts and District Councils-wise distribution of these Scholarships.

The value of each Scholarship shall be Rs. 15'00 and Rs. 25'00 p.m. per head for Categories (a) and (b) under Rule 5 respectively.

These Scholarships shall be tenable for twelve months each year for three consecutive years in Classes IV, V & VI for Category (a) and for four consecutive years in Classes VII, VIII IX and X for Category (b) subject to satisfactory progress and attendance of the Scholarship holders in any recognised Institution in Mizoram.

7. **ELIGIBILITY AND CONDITION :** (i) Only the Children/Wards of the bonafide permanent residents of Mizoram taking regular education in any Institution in Mizoram shall be eligible for these Scholarships, Subject to the condition that students who fail to take the examination for any reason whatsoever at one chance shall not be considered for these Scholarship.

(ii) No Student found guilty of mis-conduct and/or breach of discipline shall be eligible for these Scholarships.

(iii) No student shall be eligible for these Scholarships if the joint annual income of the pay range/guardian exceed Rs. 7,500/-. Income for the purpose of this Rule shall stand for what is covered under this word in the Central Income Tax Rules.

8. **AWARDING AUTHORITIES :** On the result of the examination and within the stipulations contained in these Rules and Sub-rules, the Director shall announce the names of the winners of these Merit Scholarships for the various Districts and the District Councils of Mizoram and the concerned Deputy Inspector of Schools shall pay the Scholarships regularly to the holders from the allotment of funds intimated to him from the accepted year to year budget provisions.

9. **SUPPLEMENTARY CLAUSES :** (a) The Government may, if it considers necessary delegate that power under Rule 8 to the extent deemed appropriate to any other of its Subordinate authorities.

(b) The Government reserves the right of adding to or altering these rules provided that such additions and alterations shall not be permissible in respect of the rules fixing the value of each Scholarship as also the number of Scholarship in each of the Categories (a) and (b) in Rule 5 without prior approval of the G.O.I.
