"Starting from Tahreuh kawn at the vicinity of Tualbung village. It goes straight towards North till it meets Lungpher saddle. Thence it follows Bubban inter-village path and comes to Buangkawn and then it follows Vaidawrkawng and meets Tuichhuahlian stream at Vaisam mual. Thence it comes to Filhte and then goes straight through Ramtlang and come to link saddle above Khawkawi village. Thence it goes straight to Rahai Verg mual along the upper portion of the jhum area, it comes to the end of Pethinu lunglen tlang. Thence tur-ning towards west it comes straight below the cliff of Liana than tlang and the old cultivation in Pehlawnzo to Longthikham and then to Tlangpuite saddle. Thence turning towards south it goes straight below precepiece of Thangpui and join the S. T. C, Road above the sugar cane cultivation of Dailova. It then follows the S. T. C.
