NOW, therefore, in pursuance of sub-section (2) of section 14 of the Representation of the People Act, 1951 (43 of 1951), the President is hereby pleased to call upon all the parliamentary constituencies to elect members in accordance with the provisions of the said Act and of the rules and orders made thereunder.

New Delhi Dated 10 February, 1977 Magha 21, 1898 (SAKA)

S.O. Whereas the President of India has, by notification published in the Gazette of India on 10 February, 1977, called upon all Parliamentary Constituencies to cleet members to the House of the People;

Now, therefore, in pursuance of section 30 of the Ropresentation of the People Act, 1951 (43 of 1951), the Election Commission hereby appoints:-

(i) with respect of each of the said elections :-

- (a) 17 February, 1977 (Thursday), as the last date for making nominations;
- (b) 18 February, 1977 (Friday), as the date for the scrutiny of nominations;
- (c) 21 February, 1977 (Monday), as the last date for withdrawal of condidatures; and
- (d) 22 March, 1977 (Tuesday), as the date before which the election shall be completed.
- (ii) for each State specified in the Schedule below, with respect to the election by any Parliamentary Constituency specified in column 1 below, the date or dates specified against it in column 2 thereof as the date or dates on which a poll shall, if necessary, be taken in that constituency or in the area comprised within the Assembly Constituency specified in column 3 against each of the dates.
